






During the past year, country music has been the significant in-Juence in rock music. Almost a cult of fans have gotten behind country inspired bands such as The Band, The Youngbloods, Poco, and The Flying Buritto Brothers. The emphasis is on simple country or Blue Grass as in the case of The Band.

Blue Grass is a form of country music developed by string-bands from the heart of the southern Appalachians. The name was coined in the mid-thirties after a group called Bill Monroe and his Blue Grass Boys. This particular group "Early Blue Grass" as well as many of the songs having been recorded in the 1930's.

Songs with names like Windy Mountain, Going To Georgia, and Little Bessie are done by groups like The Lonesome Pine Fiddlers, Roy Hall and the Blue Grass Entertainers, and Charlie Monroe and his Kentucky Pardners.

Blue Grass music has made a great contribution to music. It's simple, honest, acoustic and sometimes religious.



SEX EDUCATION FACT AND FANTASY

A REPORT BY LORRAINE MEINCZINGER

It is very probable that we all agree that some form of sex education is essential for the children of this world. Whether it would be educationally instituted or through a system, the age-old system of family and personal experience.

Sex, as defined by a dictionary has various meanings, one not being any more or less factual than the other.

Sex education - the education of persons to sex and its count-erparts.

Is sex education required? Should children be taught to think clearly about themselves and the world, and should emotional education be taught in the first grade or sooner? Is there a certain way or method that education of this type should be carried out?

Sexologist, Dr. Stephen Neiger, feels that "even though most teachers are trying to do a conscientious job, they are not really adequately prepared nor are they sufficiently supported by the school board, due to fear of parental objections". He also feels that sex education should start in kindergarten. He claims that a child is exposed to sexual flirtation watching Popeye as in the cartoon shows Olive Oyl flirting with Brutus, a brutish man whom desires Olive Oyl.

Contrasting to this, William B. McGrath, M.D., feels that "sex education should not be taught in grade schools and anyone who would deliberately arouse the child's curiosity or stimulate his unready mind to troubled sexual preoccupations is wrong morally". Which one of these two men do you feel are most correct? Or do you feel that neither, or maybe both of them are correct, even wrong?

In 1969 a Bill was introduced to Edmonton "to prohibit compulsory sex education in the Public Schools". The Bill provided that classes in which the human reproductive organs and their functions are processes are described, illustrated or discussed, may be given only to children whose parents request them specifically and in writing. Is this the type of education you would like your child to learn, or would you prefer that sex education, a natural phenomenon, be introduced when you felt he or she were old enough to understand it? Should one fight sex education?

Are children who are taught about sex by their parents really the lucky ones? No one is better able to judge the need, the timing, or the opportunity better than ones own parents, who teach with tender solicitude, more loving care, more Christian modesty or with greater tact. Or would you

prefer that your child be brought up blind to the facts? Do you want your child to learn that which is forbidden to be spoken about at home, in the back alley behind the house or in the playground at school?

Sex education is a moral problem. "To acquaint children with the physical side of sex without putting it in its moral context is to encourage them to use sex as they like, whether what they like is moral or not." Is this a proper way it should be taught?

Recently a form was sent out to parents with students going to Victoria Composite High School requesting the signature of the parent or guardian to permit the child to take part in a two-week educational program. Subjects ranged in four areas: Drugs, their use and abuse, Meeting Family Problems, Sex Education and Personal Communication Problems. Would you, as a parent, have signed this paper? Would you, later having children, wish them to partake in this educational program pertaining to the problems they face every day, or would you request their absence during this time and let them be ignorant of the facts?

Sex and family life education is becoming a part of the school curriculum - are you prepared to meet it?

The Latency Period: a phase of personality development during which the healthy child is not interested in sex. An age ranging from about five years until adolescence. Adolescence being the age of growth from childhood to man or womanhood. The latency period affords the child an opportunity to develop his own resources, his beginning physical and mental strength. He will investigate his own problems and try solving them himself.

In June of 1969, a report was in the Journal that "emotional education" should be taught in classrooms as part of the regular school program. Children should be taught to think clearly about themselves and the world. Do you therefore feel that a program of personal and family-life education in the school would therefore be concerned with developing effective inter-personal relations and attitudes to serve as a specific basis for making meaningful moral and ethical judgements? What do you feel about your child's or your future children's availability to this method of education?

Some books have been published to help the parents teach their youngsters the "facts of life". Some of these books use animals as examples. Do you wish this child to be educated as to human sex or animal ways, even though man is an animal? Some books make references to "God the Heavenly Father's Plan for creatures on earth". Is a more humanistically oriented family entitled to look elsewhere for six information for their children or must every child be taught the

same thing, the same way?

When newspapers or magazines run poems or articles on sexual topics, they're often swamped with abusive letters criticizing the material as "unfit for family consumption" yet stories on murder, theft, cheating and international mayhem (intentional crime against a person unable to defend himself) are published with comparatively little comment.

Every intelligent parent knows that his child is getting a sex education however distorted from the world around him. Some feel that the most effective methods of teaching children about sexare in no-holds-barred question and answer periods, and in small discussion groups instead of exclusively of lectures, films, books or tapes.

The central purpose of sex education; the study of differences and similarities between the attitudes, feelings and reactions of boys and girls is destroyed if all-boy or all-girl group discussions are used, although some kinds of information is best handled separately, for example, discussion of menstruation. Emotionally boys and girls may get a better understanding of how members of the opposite sex feel.

When teaching your children, will you teach the different beliefs on sex, or do you have one biast opinion that you refuse to change? Therefore, is it safe to assume that the only intelligent discussion of sex, in the classroom, must present these differing beliefs. "Traditional conservatives" as defined by Dr. Isadore Rubin, are the people who still believe that the sole purpose of sex is the propagation of the race. To those who hold this belief, abortion is an unthinkable crime; birth control and masterbation (a word that is not even in a popular dictionary!) are wrong because they defeat the intrinsic purpose of sex and, of course, pre-marital and extramarital sex are forbidden because children cannot be produced in a socially acceptable setting. Are you a traditional conservative?

A "neo-conservative" according to Dr. Rubin, is in favor of chastity and virginity, but not for the traditional reasons. The neo-conservative welcomes discussion and favors sexeducation. Do you fit in with the neo-conservatives or are you a "middle-of-the-road believer or of-ten termed "relationship" or situational ethics, meaning that no act can be judged as being intrinsically right or wrong, but must be seen in context of future effects.

"Personal Liberalism" or "fun morality", is a belief that is derived from a single principle. The principle in personal liberalism is simply that "Sex is fun and the more sex, the more fun"

"Social radicalism" is a moral

stance usually taken by people who believe that society must be drastically reshaped if any sexual happiness is to be realized by the individual. Which one of these types are you?

Should an older student be given all the facts? By the time an adolescent reaches man or womanhood, should be familiar with all aspects of ones personal life or should society leave a breach in his education to be "filled up by his own mistakes instead of the mistakes of others"?

In addition to a calm and neutral appraisal of varying moral codes, sex education, to be realistic, must deal in the higher school grades with a wide range of sexual information: social norms of sexual behaviors in youth and adults; sexual deviation; and various aspects of marital sex, including contraception.

Dr. Rubin also believes there can be no intelligent sex education in the schools without parallel programs of education for adults generally. Do you agree with him or do you feel that you are presently informed enough and do not need any further information on the subject? He also feels that "sex should be the expression of our most lofty emotions; the desire to share, to be close, or enjoy, to give". Intelligent and honest sex education, starting with the education of our children, is the surest way to ensure that their sexual lives will be healthy and creative. Do you feel that this is one-mans biast opinion, or do you feel that this is too blunt a subject to drop on our "innocent generation"? The generation that now probably knows more at eight years of age than we did at fifteen.

Is premarital sex a good thing? Do you feel that it allows a man or woman to make a better choice of a marriage partner with the choice based on factors other than sex, or do you feel that the word "premarital" is a dirty word and a problem of the future?

Should there be more information given out about contraception and birth control to teenagers, or should they be blinded to this fact and taught that virginity and chastity are still the "in" thing?

The Bible preaches chastity until marriage, but in biblical times girls married when they were about thirteen, boys when they were fifteen or sixteen. To-days society postpones these ages of marriage but youth of today has a lower morality than in biblical times. Is this a fact or fantasy or is this a topic a "clean" person doesn't talk about?

Last July of 1969, a Bill 413 was introduced in California. This Bill, defined as "an essential first step toward preventing the indoctrination of children in ideas about morality fundamentally opposed to the beliefs of their parents". If this Bill came to Alberta also, would you be one to

sign it and leave your child wondering why sex education is wrong? Or would you fight back feelings that sex is one of the deepest sources of human pleasure and you want your child to be aware of this fact?

Efforts at formal sex education, while potentially useful, can be a waste of time. Worse, such efforts can be harmful in the sense of stirring up adolescent anxieties rather than helping resolve them. Courses, to be worthwhile, must be planned to supplement spontaneous learning, must deal with the age-specific problems of the young people, individually and in groups, and must take into account the qualifications of the teachers, otherwise Western society's long-standing reserve about formal sex education is justified. How "should" sex education be taught in our schools?

BLACK PANTHER "THREAT" PREVENTS FBI LAYOFFS

WASHINGTON (CUP-LNS)--U. S. justice department employees will not be affected by the recent 10 per cent reduction in American government employees overseas.

The department argued successfully that foreign-based FBI and narcotics agents were essential for "adequate coverage of major cases such as the identification, apprehension and extradition of the assassin of Martin Luther King."

They also contended foreign contracts by representatives of the Black Panther Party "pose a serious threat to our Government and demand immediate attention"

The U.S. currently maintains 550,000 people overseas in 18 departments and agencies, most of which are affected by the cut. The White House announced that 20,000 of these people would be home by June.

The decision of the justice department means foreign FBI agents will join Peace Corps volunteers on the unrestricted list. The Peace Corps will work in the dwindling number of countries that will still accept them.

THE REFORM OF IMPERIALISM IS A PIOUS WISH DEPARTMENT

NEW YORK (LNS-CUP)--Sci entists announced recently that chemicals used to diffuse oil spillage at sea are more dangerous that the oil itself.

"The usual approach is to try to remove the oil from the public eye by sweeping it under the ocean's surface by means of dispersants or detergents," said Ira Gabrielson, a biologist.

"More animal life was killed by chemicals in the Torrey Canyon accident than by the oil itself."

RYERSON BOARD MAY SUE EYEOPENER-EVERYBODY **ELSE IN SIGHT**

TORONTO (CUP) -- The chairman of the board of governors at Ryerson Polytechnical Institute has threatened to launch a 'ibel action against the student union here, following the publication of a satirical article in the January 9 edition of the student newspaper, The Eyeopener.

To drive home its displeasure, the Ryerson administration also threatened to drive away the paper's advertisers and refuse to collect student fees on behalf of the student union.

The story which drew the storm of indignation was entitled "Chairman Bill on Sodsmanship" and was credited to Bill Kelly, chairman of the Ryerson board.

The story linked Kelly's participation in sod-turning ceremonies with possible political advantages he might gain as a result of his participation.

The day after the issue appeared on campus, Eyeopener editors received a letter from Kelly's lawyers informing them of possible legal action and demanding that all available copies of the issue be turned over to the board's secretary. The Eyeopener staff refused to comply.

Later the same day (January 10) student council president Barry Hales met with acting administration president Tony Wilkinson and board member David Crombie. The two administrators were "obviously disturbed", Hales

The two outlined possible administration actions over the article: a suit against the students' union for any libellous articles in the January 9 publication; simultaneous charges for any violations of the obscenity act found in the same issue; a campaign to persuade advertisers to withdraw their support; and, finally, refusal to collect student union

The campaign to cut off Eyeopener advertising would cut off all the external aid. Refusal to collect fees would mean the financial collapse of the student union.

Refusal to collect student fees has been attempted on only two other Canadian campuses.

The University of Saskatchewan board announced December 31, 1968 they would not collect Regina Campus student union fees unless the local student council censored the student newspaper, The Carillon.

The move by the U of S board failed in the face of prolonged resistance by the entire Regina student body.

The University of Guelph administration announced in November. 1969 that they would not collect student union fees this semester if less than 50 per cent of registering students opt for membership in a voluntary union. The Guelph announcement followed defeat of a student referendum calling for a compulsory___ check-off of fees.

RYERSON BOARD OF PUBS. SUPPORT EYEOPENER

TORONTO (CUP)--The student board of publications at Ryerson Institute of Technology Tuesday (January 13) voted to back up the student newspaper The Eyeopener, in the face of possible court action and other reprisals from the Ryerson administration.

The chairman of the five-man publications board broke a tie vote to reject a motion by student council president Barry Hales which called for increased control over The Eyeopener and for a vote of censure against editor Walter Dymtrenko.

Hales' motion was forwarded to "appease the administration", according to Dymtrenko. The motion followed a meeting between the council president, acting administration president Tony Wilkinson and board of governors member David Crombie January 10, where Hale was informed of possible administration reprisals for a satirical article which appeared in the January 9 edition of The Eyeopener.

The article, credited to Rverson board chairman William Kelly, discussed a hypothetical sod-turning ceremony where Kelly officiated, and speculated on possible political advantages he might gain from the ceremony.

At the meeting with Hales, the administration threatened to launch libel actions, lay charges for any obscenity which might have appeared in the same issue of The Eyeopener, drive away Eyeopener advertisers, and possibly increase the collection of

fees for the Ryerson students' union.

"The student union, being weak, presented itself as an easy target for the threats of the administration," Dmytrenko said.

"The administration has been unable to legally get at the paper," he said, "and especially at political columnist Roger Carter, who has been needling the board of governors each week by exposing their supposedly confidential and top-secret information."

COLLEGE APPOINTMENTS

Education Minister Robert Clark has announced the appointment of persons who will serve on boards of governors for public colleges in Grande Prairie. Red Deer and Lethbridge.

The appointments, effective January 30, were approved through orders-in-council is sued by the provincial cabinet and have the effect of establishing boards of governors for the colleges.

The appointments were required under provisions of the Colleges Act proclaimed last October. Previously, various local bodies nominated representatives to junior college boards.

More than 100 nominations suggesting persons who would serve on the new boards of governors were forwarded to the Alberta Colleges Commission by various bodies in the province.

T.M. Donnelly, a prominent educationist with the Red Deer Separate School Board, was named chairman of the board of governors of Red Deer College. Jerome Robbins was reappointed chairman of Lethbridge College

board, and Dr. H.J. Quinn, a dental surgeon, was appointed as chairman of the Grande Prairie College board.

Appointments to the Red Deer board from the public-at-large: J.C. Masson, secretary-treasurer of the college; Dr. R. Hay of Rocky Mountain House; K.G. Haiso, a life insurance agent and present board member; and Neil K. Leatherdale of Olds, a former president of the Alberta School Trustee's Association and member of the ASTA executive.

Wayne Lalor, a physical education instructor at the college, was appointed as the academic staff representative, and Mr. D. Riley was named as the student association representative.

Appointments to the Lethbridge board from the public-at-large: R.D. Gruenwald, president of the ASTA and trustee with the Lethbridge Separate School Board; R.D. Livingstone, a present collegel board member and Lethbridge trustee; Mrs. C.D. Redfern, a laboratory technician and present board member; and Mr. J. Chomany, who is also serving on the present board.

E.W. Ivison, an assistant professor of chemistry, was named as the academic staff representative, and Mr. V. Stapleton was appointed as the student association representative.

The following persons were appointed from the public-at-large as members of the Grande Prairie board: E.W. Martin, a present board member; H.K. Hanson, a member of the Grande Prairie recreation board: Mrs. I. McIntosh, present board member and executive member of the Alberta Association of College Administrators; and A.N. Douglas, a Grande Prairie bank manager and member of the Grande Prairie chamber of commerce.

G.A. Ross, an English instructor at the college, was selected to be the academic staff representative, and Miss L. Ayre was appointed as the student representative on the board.

An announcement on appointment to the board of governors of Medicine Hat College is expected soon. An announcement on appointments to the Mount Royal College board in Calgary is pending.

The events that have occurred in the past twenty-five years have shown that the United Nations is failing as a united world body for peace. The so-called "United" Nations is really not united at all. Each country is trying to get all it can from the other countries without giving anything in return. It can discuss war problems while the war continues to ravage right in front of its' very eyes. 

Following in the footsteps of the League of Nations, the United Nations is on the verge of collapse. If the member countries are unwilling to co-operate, they themselves will be the ultimate losers. Unfortunately the charter of the United Nations is pretty poetry - lovely to listen to but meaning very little to precious few.

Speaking before a world development conference at the United Nations headquarters on May 9th, 1969, Secretary-General U Thant stated that "the world has about ten years left to solve its problems." He went on to say that at the end of ten years the problems "will have reached such staggering proportions that they will be beyond our capacity to control."

The cold, sobering fact then is that if we don't solve our problems NOW, very shortly we will be an extinct race on a dying planet.

SUBMISSIONS DEADLINE BY COMMISSION ON EDUCATIONAL **PLANNING**

Alberta's Commission on Educational Planning has announced that It will consider submission received within a reasonable period of time after the official March 17 deadline.

This decision was made in response to enquiries from several organizations and individuals who anticipated some difficulty in completing their work by that date.

Dr. Walter H. Worth, Commissioner for Educational Planning, said: "Public response to our call for submissions had been very encouraging. More than 100 individuals and organizations have already indicated to us that they will be participating.

"Moreover, we know of others who intend to make submissions but have not yet formally notified us. In addition, there are probably others of which we are unaware."

The Commission has also announced its tentative schedule for public hearings throughout the province.

From mid-April to mid-May, the commission will sit in Grande Prairie and other points in the Peace River district, in Edmonton, and at other centres east, north and west of Edmonton where sufficient interest has been expressed in the work of the commission.

From mid-May to mid-June, the commission will hold hearings in Calgary, Red Deer, Lethbridge and Medicine Hat, and in other communities throughout central and southern Alberta.

LONG BEACH PROFS. **SUSPENDED**

LONG BEACH, Calif. (CUPI) --Officials at Long Beach State college here said Tuesday (January 13) that two sociology professors who showed nude models and a stag film to their class probably will face charges of unprofessional conduct.

Donald Robertson and Marion Steele were suspended from the faculty after Monday's (January 12) co-educational class in "social myths in American society."

In the class, the models"two men and two women--assumed poses of nine life-size nude statues banned from campus last spring.

The statues, master's thesis work of a graduate student in art, depict such scenes as a nude woman leaning out of a television set and a male and female slouching in chairs.

The stag movie was one of three movies simultaneously shown during the class. The other two were an animated film on human reproduction and a training film of the nearby Downey Police Department on the handling of civil

Robertson said the purpose of the lecture was to illustrate that violence and killing are more obscene than frank sex.

"Our society ignores glaring obscenities...and prudishly focusses on sex," he told the class. "This produces hangups which keep millions from enjoying genuine sexual pleasure and makes our entire world obscene."

U.S. CAMPUS **ADMINISTRATORS** CONFIDENT

HOUSTON, Tex. (CUPI) -- A feeling that "the worst is over" for campus administrators prevailed at the annual convention of the Association of American Colleges, which ended here Tuesday (January 13).

"My own view is that we have reached the crest in student disputes," said Edward Bloustein, administration president of Bennington College. "At this meeting last year, you saw the most frightened group of men you've ever seen. They were asking everyone for advice, including the bootblack outside the hotel.

I have figures out a relatively quick, easy, and convenient way to administer a combination intelligence and personality inventory at NAIT. This test requires that each person do only that which comes naturally. It requires almost no extra equipment or supplies. The only extra personnel that is falling and rising into the paper are required are the watchful and observant eyes of the observers who very carefully, and in a non chalant manner, record their accurate observations (preferably from a hidden position).

This test would take place in the NAIT cafeteria as the NAIT personnel go through the routine of standing in the food line, gathering their food, standing in the cashier line, and then walking into the cafeteria.

There are several subtests to the total Hughes-Naitian Intelligence and Personality Inventory. Only one of the possible subtests will be explained below briefly. For added information it is repiated considerably.

Now, if the person standing at the falling water spot in the NAIT cafeteria: (1) puts his paper cup under the falling water immediately, and (2) puts the ice pieces (1. 2. 3. 4 or more) in the paper cup quickly and smoothly as the water cup, and (3) succeeds in placing the ice pieces in the paper cup as the water is rising in the cup before the water reaches the top of the paper cup, it can be concluded that he has at least average intelligence on this one subtest, as he has clearly demonstrated some of his organizational ability, combination thinking, insight and concern for others. In addition to gaining points on his personality assessment, he will affect positively the actions and attitudes of other people in the cafeteria. (The number of ice cubs used also is of considerable significance, especially in analyzing the personality).

An added aspect to this subtest is the timing and manner in which a person removes his paper cup from under the open tap. If he removes his cup as it is filling, drinks part of the contents (water, I assume) and then puts it back under the open tap for a refill, the following hypothetical conclusions might logically be reached: (1) he is thirsty because he has been exercising on the track or elsewhere,

(2) he is thirsty for some other reason.

(3) he is testing the water before he fills his cup. He might be a very cautious and careful person,

(4) he feels that he needs more than one glass of water with his meal and does not wish to use up two paper cups. This person would likely be a compromiser because he looks after his own physiological needs as well as keeping down costs for the school,

(5) he might be drinking part of the contents of the cup then getting a refill for a combination of the above reasons, or for another pseudo logical reason.

This, more or less, concludes the Falling Water Subtest of the Hughes-Naitian Intelligence and Personality Inventory. There are several other subtests to the total inventory. In order to sample a sufficient number and variety of behaviors a person should go through the other subtests as well, which can, by the way, take place in the NAIT cafeteria. Just in case a person doens't drink water another subtest of the inventory can

be substituted in its place.

Because of limited space many of the details of the Falling Water Subtest were eliminated from this article. For example, points are given and taken away according to the actions of the people being tested. 



Among factors cited as contributing to the new-felt confidence were:

* a feeling of "expertise in handling student disorders";

* an apparent shift in student activism toward what administrators considered "more constructive" protests, especially over environmental problems;

* greater administration preoccupation with money in the face of a squeeze in government and private funds for education.

At least one conference delegate was disappointed by the apparent decrease in anti-administration activity on campus: George Wald, Nobel prize-winning biologist from Harvard.

Wald has argued that students are justified in their attacks on a "corrupted" older generation.

"When it gets warm again, I kind of feel the students will go into the streets again," he said.
