B.A.S. has done it again

I as an involved Business Administration student am sick and tireds of the horse manure that the B.A.S. council is continually handing out to us. There was an understanding between the students of Business Administration and the council on how the grad rings and the graduation were to be paid for, but this was just a big lie. We were told that those students who were involved would have a large part of their graduation and rings paid for by B.A.S. Now, due to the efforts of a few incompetents who are trying to hide their failures, we will have to pay between 15 and 25 dollars for our rings and also pay for most of the cost of our graduation. The understanding at the first of the year was that those who were involved would only pay five dollars for their rings and their graduation would be free.



This topic is one I am sure every one thinks about. In this column, I will try to explain the do's and don't's about the purchase of stereos.

In the purchase of a stereo, the first thing to consider is whether to buy a component set or a cabinet model. I would advise anyone who thinks seriously about stereo and moves a lot, not to buy a cabinet model. The first reason is obvious, it's too damn heavy. You are also paying a great deal for the cabinet to in turn your sound will suffer. But surprisingly, we still have people who want secondly the sound which is OK providing they can pay \$800 and up for a stereo, this way they get furniture plus the sound. Another

point to consider is the equipment in this cabinet, if there is a take deck and turntable plus tuner amp you might break something. Then they pull your whole unit and press to no sound. Another point is, unless you have a stereo hand made, you have no choice as to the equipment in the stereo and if you want something better, you have to sell your whole set or have two of one piece ex-tape decks or turntables.

On the other hand component models you can repair or replace any piece of the system without disturbing it. For me, this is one of the most important selling points of component systems.

The Amplifier

This is the backbone of any system for literally this is the heart of it: the most important part of the system. When you buy it consider these points:

1) Its power

2) Does it do everything you want it to?

3) Plus Everything you will want it to do before you sell it?

4) Do its looks appeal to you? For the first point - its power, this can sometimes be very decieving for amps may be 1800 watts peak music power and the shop or salesman will say it is one of the highest rated amps in the world which in fact means little or nothing other than to impress your friends. If you look further into the specs or ask the salesman and if he tells you, you will notice the power is then broken down to the IHF wattage, which is the same amp as mentioned above would be 90 watts IHF. This is the first power rating to take seriously because this is in fact the wattage of the amp when it is running. Going further you will find another power rating, this is R.M.S. and this is the power at the speaker ends. In the same machines it will be 45 watts R.M.S. If any of your friends know stereo,

this is the wattage. They gauge amps, in R.M.S. This was a simple breakdown showing you how little the peak music power rating is when considering power of an amp. The example is not really that exact, for the R.M.S. of an amp rated at 180 watts would be probably 17-22 R.M.S. which is not that bad. Now that you have seen the ratings work you must hope for precise

ratings from your manufacturer or great faith in your dealer.

Another point to consider is that warranty on the amp. These can run from 30 days up to 3 years depending on the price and quality of the machine. Another point to consider is, does the dealer stand behind the products he sells. In the amp, the next thing to consider is the back of it-does it have a place to connect everything you want to connect to it. Tape deck, magnetic cartridge changer, A.C. plug in, 1 or more speaker jacks, circuit breaker or fuse. The back of an amp is more important than the front of it, but don't expect too much out of a cheap amp., but get everything you want out of an expensive one.

The next thing to consider in an amp is whether or not to get a tuner? It is advisable to get one if for no other reason - the price. If purchased separately it will cost \$150-\$200, whereas if purchased in the amp., it only costs \$50-\$60 more than the amp. Many hours can be enjoyed from the F.M. stations. They go from rock, blues, jazz of CKUA to the F.M. stereo station CFRN which plays classics-modern, vocal, bands sounds.

In closing the part about the

speakers makes good sound, for that's probably the only person you'll be kidding; yourself. Buy a more expensive ampand cheaper speakers to start, that way you'll enjoy the sound. SPEAKERS

When buying speakers consider these things:

1. Rated wattage

2. What you want them for.

3 Size

Speakers basically take electrical energy, being the signal, and turning it into mechanical movement in the speaker. All a speaker does is move air. The more air it moves the more intense the sound, thus, air suspension speakers are very good for base response because, they move a lot of air. Speakers are rated in watts. This you can refer to your R.M.S. ratings to see if your amp. will overpower your speakers at maximum volumn. A very large amp can destroy a small low rated speaker if the power to the speaker is strong enough (volumn turned to maximum). Whereas a small amp could not blow a very large high rated speaker.

In Speakers, there are some good and some bad in all price ranges. Find a dealer you trust, the ratings to select the speakers right for you and right for

your amp, in your price rang. TURNTABLE

This is one part of a stereo system that is very flexible. A-gain some main points to consider:

1. Is it compatible with your equipment?

2. Does it do what you want it

3. Do you like the looks?

Most people buying turntable buy the one the dealer recommends to them. This in some cases can be good, providing it is a good dealer. In considering turntables the main difference is, some are pre amped to take magnetic cartridges which takes a lot a static out a far better tape than the other type (the crystal cartridge). But make sure your amp is preamped to take a magnetic cartridge before spending the extra money on a magnetic cartridge changer - some changers can take both magnetic and ceramic if they are magnetic changers a ceramic turntable can take ceramic only.

In closing I would like to leave you with the hints for buying a stereo.

Find a good reliable dealer.
 One that stands behind his merchandise (the factor is usually a long ways away).

3. Find merchandise that does what you want, in your price range.

4. Take it home and listen to it. If you doubt it in any way, you're much more critical in your own home.

5. Don't be talked into buying over your head.

Vega

Vega, car for today's generation? General Motors developed the Vega to the tune of \$200 million dollars. G.M. researchers took an extensive survey of thousands of car owners in an attempt to evaluate their opinion of what a sub-compact car should emulate. A main consensus was, "You get what you pay for, but they want to know what it. is. Little cars are not sold to poor people. Their buyers are critical, and thoughtful." To fulfill this demand G.M. produces four different model Vegas-sedan, coupe, wagon, and panel truck.

Edmonton Motors supplied us with the basic Vega sedan for our road test. It was equipped with the 90 H.P. (140 cu. in. Vega aluminum block engine), 3 speed floor shift and front buckets. A menagerie of options are available for the Vega-111 H.P. (140 cu. in.) mill, 4 speed floor shift, 2 automatics (air cooled Chevy Powerglide and a semi-automatic which is manually shifted without the use of a clutch), air conditioning, sports options, etc.

Offered as standard equipment are front disc brakes, flow through ventilation, independent coil springs in front and coils in the rear. Built in safety features of the Vega are side beams in the doors and built in head rests on the front bucket seats.

The Vega's smooth ride characteristics spring from the fact of low spring and hydraulic shock action. Sports car handling was achieved through the use of a recirculating ball steering gear. Wheelfight and road shock were also reduced by this method.

Interior appointment was found to be functional. Comfortable seating arrangement with adequate head room resulted from G.M.'s modified reclined seating. The test team found this arrangement to be quite comfortable, front and back, leg room rather astricted in the rear. Disappointing factors of the interior were the inaccessability to the door locks and the close positioning of window cranks to door storage areas.

The test team though exterior refinement could be improved by placing the hood latch (which is manually locked) on the same side of the car as the oil dip stick. Slight restyling of the wheel wells may reduce paint chips from rocks thrown up by the front wheels. Trunk appearance could also be improved by a cover over the horizontally exposed spare tire.

Body styling was liked by the test team. Noted were the bolt on front fenders and headers to cut repair costs. Low wind noises was also noted in window areas, plus the added advantage of no draft when windows are down. A significant design factor for the Vega,

An acceleration test by the team proved impossible on our Vega due to its low mileage (7 miles) when received. Performance specifications were gathered from G.M. to give you an idea of the Vega's ability.

Evaluation of the Vega with no definite prerequisite set is difficult. Each person requires a vehicle for their own individual needs. Mechanically, the Vega rated well in the teams views. Slight modifications, as previously stated would be appreciated. Road handling was good, precise, comfortable with slight rear wheel hop when cornering on rough roads. Finish quality appeared high on the models viewed. Appointments were well placed and highly functional. The availability of numerous options able the Vega owner an opportunity to fully stylise his car.

Gremlin

Gremlin is American Motors answer to the sub-compact car market for the '70's. To me this rig rates high in economy (\$2395), comfort, safety, and quality engineering. I test drove a Gremlin courtesy of Devonian Motors last weekend. To assess it for myself.

The engine options, American Motors provides, proved to be quite adequate. They are 232 cu. in. delivering 135 H.P. and the 258 cu. in. 150 H.P. version, both six cylinder models. Contrary to popular belief, these engines have been in service for approx. six years and have proven themselves a very reliable power plant.

This little animal gets the power to the back end through a Borge-Warner designed transmission. To those, not in the know, the Borge-Warner transmission is one of the best in the industry. Three styles are available, three speed column, automatic, and floor shifters. The floor shift appears to be the best, as the column tends to hit reverse on the long throw from first to second gear and the automatic can easily hit neutral when shifted manually. These transmissions all seem to deliver maximum torque to the rear end where it can again be improved by the optional limited slip differential.

This assorted hardware in hung on independent coil suspension on the front and parallel leaf springs in the rear. The wheelbase spans 95 in. resulting in a sports car type ride. The majority of road bumps are taken up by the suspension but it still results in a choppy ride on rough roads.

A definite help in smoothing out these rough roads are the seats of the Gremlin. Buckets and bench are available both having the built in headrest for safety. This is the area in which my biggest beef lies with the Gremlin' its headroom' there is none for the average six footer. In my opinion American Motors lost a lot of the prospective market by poor design characteristics such as this one. The four seater (with the lift up back winder for easy loading) is like most of the small car field and does not allow enough leg room for the adult passenger in the back seat. Hip and elbow room seems completely adequate in both front and rear seats, but leg room in the front for the driver is obstructed by the steering column. This could really be a problem if the front seat is pulled ahead to afford more room for back seat passengers.

American Motors has provided good quality instruments, well within sight and reach, but as in many of today's cars, is depending on idiot lights rather than gauges. For those who do like the gauges they can be had as options. The heater controls are in easy reach and supply the car with a more than adequate amount of heat for size of car. So far those who think a small car also means an insufficient supply of heat and defrost control your worries are over in this little animal. Those who really get uptight, air conditioning is available on the 150 H.P. model.

Performance buffs may not be overly enthusiastic by the Gremlins acceleration charts but the supplied engines rate well in their leagues.

Rear end ratious of this little beast of 3.08/1 perform as follows: 45 mph. @ 4300 rpm. inlst., 77 mph. @ 4300 rpm. and 74 mph. @ 3000 rpm. The factory engines are the 232 and 258 cu. in. sixes but the 304 or 390 cu. in. V-8 models can be dropped right in and that rates high in anybody's mind.

Quality design and engineering which I observed in the Gremlin should constitute a good selling point for American Motors. The car serves as a family second car or a highway touring car. It is affected little by cross winds, a characteristic not often shared by cars in its weight class of 2600 lbs. American Motors has acquired a reputation for well constructed cars and I think they will maintain this asset in their Gremlin Lineup. They have a new design, proven engines, good transmissions, more than adequate heating and defrosting systems and a practical price. Really, isn't that what a car is all about?

"The Association shall function in such a way as to induce public interest in student affairs and further to represent the Association's interest to the:

- 1) Federal Government
- 2) Provincial Government
- Business and Industry (employment)
- 4) Citizens and Communities
- 5) and other organizations"

"The Associations hall strengthen ties between member students unions to provide a braoder perspective for students and citizens."

"The Association shall provide those services which are requested by member students' union and which are deemed proper and feasible."

"The Association shall make available information regarding post-secondary education, the operation of students' unions and the Association itself."

"The Association shall consist of students unions of post-secondary institutions in Alberta."

"The Association defines postsecondary institutions to include Colleges, Schools of Nursing, Technical Schools, Agricultural Schools, Vocational Institutes and Universities."

The price of membership is \$.50 per student, which is taken out of your student fees.



And if you haven't realized or heard lately the rate of employment is slo-wly decreasing! With this problem, beggars can't be choosy, when it comes to applying for a job. Sure, when you are putting applications in a number of places, you become specific about certain positions. Nevertheless, don't become so discouraged after a refusal and give up. Sit down and think about yourself, the kind of job you would like and how to go about getting it. Having set a goal--work for it.

When word goes around on the job situation, everyone becomes a little discouraged and quite worried. We have an employment office at NAIT but you can't depend fully upon them. Get your self in gear and look in the paper or go forth and present yourself to the public as a willing hard worker. Another item of interest concerning future employment is the fact that the university crowd is out at the end of April and you

can bet there is going to be quite a hunger for jobs. If you don't want some competition, what do you say gang?

Most of you have heard the phrase "you have to pull to get anywhere, nowaday". It's true, no denying it, but it is sure no excuse for giving up. It's nice to have a "few strings" pulled but a person feels a better sense of achievement if he has gone out and worked at it himself.

People do not like being pushed because it becomes boring after a while and causes a feeling of resentment. Don't doubt yourself, you're as good as the next guy, if not better in some ways. "If you don't succeed, try, try again" (taken from experienced people).

As a NAIT graduate or someone looking for summer employment, you are qualified in the training you have been taught. Employers should consider (mind you, some do) this is just as equal to personal experience. With confidence in your personal attributes and talents, along with plenty of practical training, boy,

students have decided on their career goal. If your goal is set, then you must know something about that career. Since a student is enrolled in a program at NAIT, it must pertain to this career goal. Now, how about starting to work for it? That's up to the individual. A person sets up a mental picture before he or she starts something, try it for this. There will be some opportunities and downfalls, so expect both.

If you know what you want and know something about the job; confidence in yourself is built from this. As for knowing something about the job, its good to know who your interviewer is and what type of business the company does. This not only displays information for your own personal use but it indicates to the employer that you have done some research about them and he notes your interest.

To show satisfactory interest, be prompt for your interview. It ruins your chances if you are late or even too early. The employer will respect you for sparing time to talk with them and not wasting theirs or causing embarrassing situations of meeting up with other applicants. He wants to meet you but at the specified time.

So that the employer could know the best and appropriate details about the application, he has you fill out an application first. Having a resume of your qualifications becomes quite handy for

Do you look good? Are your clothes and accessories appropriate for the business approach and world? Are you "wearing" a smile when you enter? Don't carry any excessive packages or start handling your purse or gloves in a nervous fashion.

Did you ever wonder if the employer isn't just as nervous as you? He is meeting you for the first time and will find out if you can help him in any way to make his business better. Though he is just a representative he must promote the business to appeal to the applicant. He appreciates questions of interest about the business and really admires the individual who remains interested even after being discouraged. You never know if you won't be dealing with that particular business in the future.

So, when applying by letter or personal visit, have some questions to ask. Don't do it to give the impression you're interested because it will eventually show. When you go for an interview go because you want to.
