# Day Care Center

NAIT, being the progressive Institute that it is, is currently looking at expansion to accomdate the ever increasing student population.

In this expansion program, NAIT is also looking at a student and staff service, in the form of a Day Care Centre.

The purpose of the centre would be to enable full-time students and part-time students with a family to take their children to a type of babysitting service. This would allow the spouse, who may not be working due to the children, to find employment.

The centre, especially designed for convenience, would be located on or near the NAIT campus, thus enabling the student to drop off the children before classes and pick them up after.

The facility would be open to all students and staff with children, legally married or otherwise. Because of children, many prospective students can not attend NAIT. This centre will make it possible for these students to further their education.

The cost of such a service would be substantially less than private centres or babysitting services, and in some cases allow the non-student parent the chance to work.

A feasability study in now being conducted, to determine the need for such a service; and early indications are that need does exist. The survey contains questions about the names, ages, sexes and interests of the child, all of which are of prime importance. These will help determine the program on the whole.

The survey thus far has only been given to registered married students at NAIT. Unfortunately it has not reached the single

#### PARKING STICKERS

By S/SGT JOHNSTON

An increase of illegally parked motor vehicles has been noted in the Parkade, especially in the students, B Zone, section 5 to 14 levels.

To take effective measures to discourage illegal parking, the following procedure has to be adopted.

To enable Commissionaires and City Police to check out vehicles at a rapid rate and cover more areas, it will be necessary for renters to ensure a decal (in the case of students the decal designated for the front windshield - and especially the decal designated for the rear window) is affixed to the window on the inside to be clearly visible.

Should the Commissionaires and/or the City Police not be able to readily identify a motor vehicle as being legitimate - due to no clearly visible displayed decal showing through the rear window, a City of Edmonton Police fine will be issued - even though a decal may be attached to the front window area.

A number of renters have displayed their decals as per the. instruction printed on the decals. If these instruction would have been carried out by all --- the checking out and reporting of plug-in power failures, etc., may have been possible.

Should you be uncertain of the method of attaching a decal to the glass (inside) window - it is recommended that the decal sticker be placed in the plastic

# SENATE BILL THREATENS

An open letter to responsible gun owners:

It seems that everytime there is a new session in Parliment we as gun owners get attention first.

As you probably have heard, the Hon. Donald Cameron of the Senate brought in a Bill S-14 that had its second reading November 21, 1974 in the Senate. Copies of this Senate, Hansard and the Bill itself can be bought through Information Canada, Ottawa, at a dollar each.

To condense the Bill, all guns now restricted will be prohibited. All rifles, shotguns, etc. that so far do not need to be registered will have to be registered as restricted weapons.

This is a useless Bill as Sen. Donald Cameron himself states, quote, "No sensible person pretends that stricter gun laws wil eliminate the use of guns by criminals. In other words, the

professional criminal will obtain guns in one way or another." End of quote.

There is a lot more which would take too long to write. However, the idea is that the criminal will not be able to obtain a gun legally, as if legality made any difference to a criminal.

He suggested that the Bill should go to Standing Committee of Legal Constitutional Affairs and they should hold hearings for anyone who wants to be heard. When and if these hearings are held, no dates have been mentioned.


bringing everybody up with him.

# CONCERNED GUN OWNERS

1st Session, 30th Parliament, 23 Elizabeth II,

An Act to amend the Criminal Code (control of weapons and firemans)

R.S., c. C-34 1st Supp., c. 11;

Her Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:

1970-71-72, €. 37

Definitions

1. Section 82 of the Criminal Code is repealed and the following

"82. For the purposes of this section and sections 83 to 106,

"Commissioner"

"Commissioner" means the Commissioner of the Royal Canadian Mounted Police; "firearm" means any barrelled weapon from which any shot, bullet

or other missile can be discharged and that is capable of causing serious bodily injury or death to the person, and includes anything that can be adapted for use as a firearm; "local registrar of firearms" means a person appointed in writing

by the Commissioner or by the Attorney General as a local registrar

"local register of firearms'

of firearms: "permit" means a permit issued under section 97;

"permit" "prohibited

"prohibited weapon" means

weapon"

(a) any device or contrivance designed or intended to muffle or stop

the sound or report of a firearm.

(b) any knife that has a blade that opens automatically by gravity or centrifugal force or by hand pressure applied to a button, spring or other device in or attached to the handle of the knife.

(c) any firearm that is capable of firing bullets in rapid succession during one pressure of the trigger,

(d) any firearm that is less than twenty-six inches in length or that

is designed or adapted to be fired when reduced to a length less than twenty-six inches by folding, telescoping, or (e) a weapon of any kind, not being a restricted weapon that is declared

by Order of the Governor in Council to be a prohibited weapon;

"registration certificate

"registration certificate" means a firearms registration certificate issued under section 98;

"restricted

"restricted weapon" means

weapon'

(a) any firearm designed, altered or intended to be aimed and fired by the action of one hand,

(b) any shotgun or rigle of a kind commonly used in Canada for hunting

or sporting purposes, or

(c) a weapon of any kind that is declared by Order of the Governor

in Council to be a restricted weapon.

#### EXPLANATORY NOTES

Clause 1: The purpose of this clause is to place machine guns and shortened guns (sawed-off shotguns), which are now "restricted weapons", in the category of "prohibited weapons It also places rifles and shotguns which are unrestricted in the category of "restricted weapons". As a result all weapons will be either "prohibited" or "restricted"

Subsection 82 (2) if the Act is repealed to eliminate the exception now existing based on muzzle or bullet velocity. Almost any firarm can kill if the victim is close enough. The definition in paragraph 82 (1) (b) is restrictive enough.

Subsection 82 (2) at present reads as follows

"(2) Notwithstanding anything in subsection (1), a firearm shall be deemed not to be a prohibited. weapon or a restricted weapon as defined in this section where it is proved that such firearm is not designed or adapted to discharge a shot, bullet or other missile at a muzzle velocity exceeding five hundred feet per second or to discharge a shot, bullet, or other missile that is designed or adapted to attain a velocity exceeding five hundred feet per second."

> 2. The said Act is further amended by repealing sections 87 and 88 thereof and substituting the following therefor:

Delivering restricted weapon

"87. Everyone who sells, barters, gives, lends, transfers, or delivers any restricted weapon to another person without the authorization in the manner prescribed by subsection 97 (1), is guilty of an indictable offence and liable to imprisonment for two years.

Clause 2: The purpose of this section is to make all transfers of weapons, whether commercial or private, subject to authorization. Sections 87 and 88 at present read as follows

"87. Everyone who sells, barters, gives, lends, transfers or delivers any firearm or ammunition to a person under the age of sixteen years who is not the holder of a permit under which he may lawfully possess it is guilty of an offence punishable on summary conviction. Everypne sells, barters, gives, lends, transfers or delivers any firearm or ammunition to a person who he knows or has good reason to believe is prohibited from having a firearm or ammunition in his possession by any order made pursuant to section 95 is guilty of an offence punishable on summary conviction.

(2) Everyone who sells, barters, gives, lends, transfers or delivers any firearm or other offensive weapon or any ammunition or explosive substance to a person who he knows or has

(b) is a person to whom the sale, barter, giving, lending, transfer or delivery of any such article by other persons is prohibited by any order made pursuant to subsection 105 (5), is guilty of an offence punishable on summary conviction."


- 3. Paragraphs 85 (b), 86 (d), 90 (b) and 91 (1) (b), section 92, and paragraphs 94 (b), 96 (3)(b), and 102 (4) (b) of the said Act are repealed.
- The said Act is further amended by repealing section 93 thereof and substituting the following therefor:


unlawful without permit

- "93. Everyone who has in his possession a restricted weapon is, unless he is a holder of a permit under which he may lawfully so possess it, guilty of an indictable offence and liable to imprisonment
- 5. The said Act is further amended by repealing section 95 thereof and substituting the following therefor:

Order prohibiting possession of firearm or ammunition

"95. Where a person is convicted of an offence involving the use, carriage or possession of any firearm or ammunition, the court, judge, justice or magistrate, as the case may be, shall, in addition to any other punishment that may be imposed for that offence, make an order prohibiting him from carrying or having in his possession any firearm or ammunition for a minimum period of ten years."













Clause 3: The purpose of this section os to make all offences relating to guns indictable ones. and consequently to eliminate all summary convictions. Section 92 becomes unnecessary due to the new section 87.

Section 92 at present reads as follows:

"92. Everyone who sells, barters, gives, lends, transfers or delivers any restricted weapon to a person who is not the holder of a permit relating to that weapon issued for the purpose described in paragraph 9 (2) (a) is guilty of

(a) an indictable offence and is liable to imprisonment for two years, or

(b) an offence punishable on summary conviction.'

Clause 4: The purpose of this section is to require a permit for all "restricted weapons which in fact includes all firearms. Section 93 at present reads as follows:

"93. Everyone who has in his possession a restricted weapon elsewhere than in his dwellinghouse or place of business is, unless he is the holder of a permit under which he may lawfully so possess it, guilty of

(a) an indictable offence and is liable to imprisonment for two years, or

(b) an offence punishable on summary conviction.

Clause 5: Under the present law a judge may order that a person involved in a crime be prohibited from possessing any firearm for a maximum period of five years. This amendment would require the judge to make such a prohibitive order for at least ten years.

Section 95 at present reads as follows:

prescribed

Exclusion

"95. (1) Where a person is convicted of an offence involving the use, carriage, or possession of any firearm or ammunition, the court, judge, justice or magistrate, as the case may be, may, in addition to any other punishment that may be imposed for that offence, make an order prohibiting him from carrying of having in his possession any firearm or ammunition during any period not exceeding five years from

(a) the time of his conviction for that offence, or

(b) if he was sentenced to imprisonment for that offence, the expiration of his sentence.

(2) Everyone who carries or has in his possession any firearm or ammunition while he is prohibited from doing so by any order made pursuant to this section is guilty of

(a) an indictable offence and is liable to imprisonment for five years, or

(b) an offence punishable on summary conviction.

6. The said Act is further amended by adding immediately after paragraph 97 (2) (d) thereof the following:

"(e) for use in hunting by a person who holds a hunting licence from the appropriate authorites.

(2A) (a) a permit described in subsection (1) may be issued only where the applicant has passed a test indicating:

(i) that he is familiar with the weapon which he wishes to possess and that he knows how to use it properly; and

(ii) that he is familiar with the laws regulating weapons;

(b) a permit shall not be granted to a person who

(i) is prohibited from having a firearm by any order under section 95,

(ii) is of unsound mind, or

(iii) is a person to whom the sale, barter, giving, lending, transfer,

or delivery of any such article by other persons is prohibited by any order made pursuant to subsection 105 (5)."

Clause 6: The purpose of this additional paragraph (e) to subsection 97(2) is to provide that permit may be granted to use a rifle or shotgun for hunting subject to the granting of a hunting

New paragraph 97 (2A) (a) makes it mandatory that a test be passed before any weapon permit may be granted. The test would deal with the knowledge and handling of weapons and the laws pertaining to them. Paragraph 97 (2A) (b) sets out those persons who are prohibited from being granted a weapons permit.

The Senate OTTAWA, Ontario

Dear Sir,

Bill S-14 being brought before the Senate by Senator Donald Cameron, dealing with fire arms is unacceptable to me for many reasons, most important of which is outlined below.

We now have good laws and the proper application and enforcement of the existing Legislation should be effective in controlling the illegal use of fire arms.

The proposed New Gun Law would not deter the criminal. Bill S-14 would entail an enormous amount of non-productive paper work and a great waste of the tax payer's money. In no way would Bill S-14 prevent a criminal from obtaining fire arms.

I will support any reasonable Legislation discouraging the criminal in the use of fire arms but I will not condone laws which will penalize the law-abiding gun owner.

We consider these Gun Laws discriminating and the law-abiding citizens are classed as criminals by these Gun Laws.


