## BB Gun 5-Meter Postal Event

PURPOSE: The purpose of this postal match is to offer Royal Rangers from across the country an opportunity to participate in a nationwide BB gun postal competition.

- PREREQUISITE: Recommend the completion of the Firearm Safety and Marksmanship merits.
- FIRING DATES: Match may be conducted by the district, section, or outpost between January 1October 31.
- All entries must be postmarked by November 15 .
- LOCATION: Match may be conducted indoor or outdoor.
- ELEGIBILTY: Individuals may enter this match only once per calendar year. All competitors must be members of a currently chartered outpost.
- FEES: $\$ 5.00$ per Individual / \$15.00 for team (4 members per team)
- All team members must enter as individuals.
- ADMINSTRATION: Contact the NRA Competitive Shooting Division to receive the score reporting forms. Direct questions to the Postal Program coordinator, at Postal@nrahq.org or (703) 267-1482.

- RESULTS: Results will be tabulated and released after December 31. Individual and team awards will be mailed soon after the release of the results.
- CATAGORIES: Each age group will comprise a category. Eight (8) through fifteen (15) years old may compete in this match. Compete using age attained in the calendar year of competition.
- AWARDS: The National Royal Ranger Ministries will present awards for $1^{\text {st }}-3^{\text {rd }}$ place in all categories, individual and team events.
- INDIVIDUAL AWARDS: Individual awards will be presented from the NRA Competitive Shooting Division for $1^{\text {st }}$ place in each category.
- Additional awards will be provided for each additional ten competitors in a category. Second through fifth place will receive awards based on participation.
- First place in each category for each position will also be awarded. Additional awards will be provided for each additional ten competitors in a category.
- TEAM AWARDS: A team match is an unfired match generated by the fired aggregate scores of five (5) individual participants. Team awards will be presented from the NRA Competitive Shooting Division for $1^{\text {st }}$ place in each category. (There must be two teams for $1^{\text {st }}$ place to be awarded).
- One additional award will be provided for each five additional teams in a category.
- The team category will be determined by the age of the oldest team member.
- Any number of teams may be entered by each outpost.
- Individuals may only be entered on one team per year.
- RULES: Current NRA BB gun rules will govern this competition. Rulebooks may be ordered by contacting NRA Sales at 1-800-336-7402. Ask for BB Gun Rulebook (Item \# CC 16410).
- EYE PROTECTION: Eye protection is required during this event by all Royal Rangers.
- EQUIPMENT: The official gun for the match is the Daisy ${ }^{\circledR} 499$ series BB gun. By requiring all competitors use the same model gun, it will provide an equal balance in equipment. Individual skill should then determine final results. For information on purchasing guns, contact Customer Service and be sure to ask for "club price."

- TARGETS: Any NRA certified AR-4/10-5 meter (10 bull's-eyes) targets may be used.
- Shooter's name and the position being shot will be printed in the upper right hand corner of each target. Target acquisition is the responsibility of the competitor.
- For information on where to purchase official targets, refer to the target suppliers' section of this document.
- COURSE OF FIRE ( $\mathbf{3 0}$ shots total): All targets are fired at 5 meters. One shot per record bull's-eye. Ten minutes will be allowed to fire all ten shots for each position. Unlimited sighting shots are permitted but must be fired within the 10 -minute time limit.
o 10 shots Prone ( 10 minutes)
o 10 shots Standing (10 minutes)
o 10 shots Kneeling (10 minutes)
- SCORING: Each target must be scored by two individuals and in accordance with NRA BB Gun Rulebook. All targets are subject to review and rescoring by the NRA.

Note: Each year the top three 5-meter teams from a district level competition are invited to compete at the annual International BB Gun Championship Match, sponsored by Daisy ${ }^{\circledR}$. For more information on the IBBGCM, visit their homepage at http://ibbgcm.home.att.net/.
