Cooperative Values and Practices

INTRODUCTION:

The following guide, designed by Royal Rangers International (RRI), is intended to introduce and maintain a common set of cooperative values and practices, within the growing number of nations using the Royal Rangers ministry around the world. By establishing a shared culture, or way of doing things, the integrity, quality, and effectiveness of the ministry will be strengthened and sustained.

Using the Royal Rangers ministry is a privilege with corresponding responsibilities, outlined in this document. Nations, denominations, and churches choosing to use this adventure-mentoring-based evangelistic and discipleship program, should commit themselves to meeting and exceeding the values and practices outlined herein. Good stewardship will protect the ministry name and identity, and the reputation of Jesus Christ.

ROYAL RANGERS INTERNATIONAL:

RRI is a service organization created to strengthen and expand Royal Rangers all around the world. The ministry is led by a Director and a team of leaders, representing each of the geographic regions, and is called the RRI Council.

Each region is led by a Regional Committee, which is headed by a Coordinator. The Regional Coordinator's primary responsibilities consist of representing the region on the RRI Council, assisting nations in regard to curriculum, training and promotions, and mobilizing leaders and assets to strengthen and expand the ministry inside the region. Nations within a region relate to RRI through their respective Regional Committee and receive authorization to use the Royal Rangers ministry name and trademark by the same means.

To gain a better understanding of the purposes and goals of RRI and how it is led, request a copy of the *Operational Guidelines*.

STATEMENT OF FAITH:

The four red points of the Royal Rangers emblem represent the common doctrinal beliefs that should be agreed upon by churches or denominations using the

Royal Rangers ministry: Salvation, Baptism in the Holy Spirit, Divine Healing, and the Second Coming of Jesus Christ.

In addition, RRI has adopted the Statement of Faith of the Pentecostal World Fellowship.

1. We believe the Bible to be inspired, the only infallible, authoritative Word of God.
2. We believe that there is one God, eternally existent in three persons: Father, Son, and Holy Spirit.
3. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory.
4. We believe that for the salvation of lost and sinful man regeneration by the Holy Spirit through faith in Jesus Christ is absolutely essential.
5. We believe in the baptism in the Holy Spirit with the evidence of speaking in other tongues as the Spirit gives the utterance according to Acts 2:4, and in the operation of the spiritual gifts and ministries.
6. We believe in the ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a godly life.
7. We believe in the resurrection of both the saved and the lost; they that are saved to eternal life and they that are lost unto the resurrection of damnation.
8. We believe in the Church of Jesus Christ and in the unity of believers.
9. We believe in the practical application of the Christian faith in every day experience and the need to minister to people in every area of life, which includes not only the spiritual but also the social, political, and physical.

GLOBAL IDENTITY AND PURPOSE:

The following items are worldwide standards that should remain uniform to insure a common ministry identity and purpose:

1. The design of the Royal Rangers emblem, or trademark, should not be altered except to replace the English ministry name where necessary,

such as “Exploradores del Rey” in Spanish Latin America & Spain. (For the sake of clarity, the official Royal Rangers Emblem or trademark is pictured on the final page of this document.)

2. The meaning assigned to each point of the Royal Rangers emblem should not be changed.
3. Once a ministry name is agreed upon in any given language (such as “Exploradores del Rey”) all countries or people groups with the same language should use the same ministry name.
4. The Royal Rangers code, pledge and motto should not be changed.
5. The mission statement should remain the same, “To evangelize, equip, and empower boys for Jesus Christ.” (The word “boys” may be substituted with the words “boys and girls,” “children,” or “youth,” or a combination of these, when and where appropriate.)
6. Nations are requested to maintain a uniform for the ministry in order to create a common sense of identity and belonging among Royal Rangers nationwide and worldwide. The recommendation is to use a khaki colored uniform shirt, when possible, to maintain some level of global similarity. Furthermore, the Royal Rangers International *Leader’s Manual* provides recommended guidelines for the placement of uniform insignia and recognition items. In as much as possible, nations are urged to seek to follow these guidelines, here to, to maintain some level of global similarity.
7. The Royal Rangers Emblem should be worn on the left uniform sleeve, centered 1.5 cm below the seam.
8. Exceptions must be approved by the RRI Council.

CHARTERING STEWARDS:

The primary objective of Royal Rangers International is to partner and network with national leaders to strengthen and expand the ministry all around the world. *Our combined efforts are directed at establishing **one** self-sustaining (indigenous) national Royal Rangers ministry in each nation.*

RRI, Royal Rangers leaders, and national church leaders around the world believe that Royal Rangers is a ministry to be shared with all cooperative Pentecostal churches in a nation. (See “Availability of the Royal Rangers Ministry” below which

outlines how Pentecostal, and select non-Pentecostal main-line-Evangelical, churches may submit a charter application to use Royal Rangers.)

When pioneering the ministry in a nation, the Director of RRI, the Regional Coordinator, and the members of the respective Regional Committee, will entrust Royal Rangers into the hands of a Pentecostal church organization, herein referred to as the "Chartering Steward." A Chartering Steward in a nation is selected in the following manner:

1. Because Royal Rangers was started by the Assemblies of God, the national Assemblies of God church (or the primary national Pentecostal church with whom the Assemblies of God partners) in any given nation will receive priority option of serving as the Chartering Stewards. All other qualified churches wishing to use Royal Rangers may apply for a charter for their outpost from the Chartering Steward.
2. If there is no Assemblies of God presence in a nation (or primary national Pentecostal church with whom the Assemblies of God partners), or where the Chartering Steward at any time chooses not to serve as such (or proves an unwillingness or inability to fulfill the corresponding responsibilities), RRI will consult with the church leaders it considers necessary to make a wise choice as to which organization should be offered the Chartering Steward responsibilities. Once a Chartering Steward has been selected, qualified churches in that nation wishing to use Royal Rangers may apply for a charter from them.
3. RRI, in special cases determined by the RRI Council, reserves the right to establish itself as the Chartering Steward in a nation, when agreed upon by the respective Regional Committee, and when done in consultation with the church leaders it considers necessary to make a sound decision.

A potential or current Chartering Steward must commit itself to the values and practices outlined in this document. It must also sign the "RRI Chartering Steward Agreement," which allows a nation to use, and profit from the use of, the Royal Rangers emblem. In many cases, it would also allow for the adaptation of the curriculum without charge. The document is designed to protect the ministry's global identity and intellectual property in this day of the internet and desktop publishing. The Chartering Steward has

full access to the services rendered by RRI—primarily promotional, curricular, and training support.

Each local congregation implementing the Royal Rangers ministry will relate to the Chartering Steward in regard to national activities, curriculum, training, and guidelines. The Chartering Steward relates to RRI, through its respective Regional Committee, primarily by fraternal or spiritual relationship, and accepted principles designed to protect the integrity of the ministry, as outlined in *Cooperative Values and Practices*.

RRI will maintain a strong and viable relationship with the Chartering Stewards through its respective Regional Committees. By design, Royal Rangers is an evangelistic and discipleship tool to assist the local pastor and congregation to integrate converts into local Bible-believing, Spirit-filled evangelical churches. It is not RRI's philosophy or desire to establish a Royal Rangers group in any given country that is not amenable to the Chartering Steward. Nor does RRI desire to control the development of the Royal Rangers ministry within a country, but rather to support it by protecting the ministry trademark, by insuring that sound evangelistic and discipleship curriculum are developed and maintained, by keeping high leadership training standards, and by coordinating international expansion. If, in the past or future, groups were/are started that use the Royal Rangers trademark and/or curriculum, but do not relate to the Chartering Steward in their nation, the Chartering Steward will seek to affiliate the group. In the event those efforts do not prosper, previous approval or permission to use the Royal Rangers trademark and/or curriculum, whether given in writing or not, and regardless of the source, will be rescinded.

It is the prerogative of the Chartering Steward in a nation to expand Royal Rangers within its borders according to the guidelines in *Cooperative Values and Practices*. It is the prerogative of RRI, through its Regional Committees, to coordinate the expansion of Royal Rangers across national boundaries, and to engage potential Chartering Stewards and enter into agreements with them.

PROCESS FOR INTRODUCING ROYAL RANGERS IN A NATION:

Royal Rangers is a very effective ministry tool when placed in the hands of called and trained personnel. For that reason, RRI recommends the following process when a nation wishes to launch Royal Rangers:

1. Royal Rangers International will choose a Chartering Steward prepared to support Royal Rangers on an ongoing basis, and in accordance with *Cooperative Values and Practices* (this process was outlined above). One person (with a cooperative spirit, ability, time and interest) must be appointed as the National Royal Rangers Commander/Director and team leader by the organization selected as the Chartering Steward. The Chartering Steward in each nation must be prepared to sign the “RRI Chartering Steward Agreement.” Upon doing so, the nation may use the Royal Rangers name and trademark and avail itself of all the RRI resources.
2. The respective RRI Regional Coordinator and Committee will make arrangements to train the National Commander/Director and the leadership team.
3. The national leaders, under the Regional Coordinator and Committee’s supervision, will adapt the curriculum, if necessary, and prepare strategies to make the ministry accessible to the churches.
4. The national leaders will formally launch the ministry. The Regional RRI Coordinator and Committee members stand ready to guide the team through this process by providing direction in three primary areas— curriculum & programs adaptation, leadership training standards and procedures, and ministry promotions.

AVAILABILITY OF THE ROYAL RANGERS MINISTRY:

At the beginning, the organization selected as Chartering Steward may exercise its privilege to present the Royal Rangers ministry exclusively to the churches within its own organization. After a prudent and reasonable time, the national Royal Rangers office should begin accepting charter applications from qualified Pentecostal churches and/or denominations outside its own church organization. The possibility also remains for non-Pentecostal churches to charter (details below). The following should be viewed as a baseline policy upon which the Chartering Steward builds its policy for making Royal Rangers available to those churches or denominations.

1. The denomination/church must acknowledge and understand the statements of faith outlined previously in these *Cooperative Values and*

Practices. The denomination or church must also be willing to continually work cooperatively and harmoniously with national Royal Rangers ministry policies and procedures, and use unaltered the Royal Rangers program. Charter applications from non-Pentecostal, main-line-Evangelical churches may be considered on a case-by-case basis only. For the sake of unity and cooperation, the church must be made aware in writing in advance that they are voluntarily joining a worldwide Pentecostal ministry. Royal Rangers may not be shared in any way, shape or form with non-Evangelical churches, organizations, or denominations.

2. The Chartering Steward must decide whether to approve entire denominations or individual churches on a case-by-case basis, or both.
3. Denominations/churches must sign time-dated agreements with the Chartering Steward to use Royal Rangers. Each nation is responsible to write this document. It should clearly state the date and conditions for renewal. RRI suggests that first time approvals be given for a probationary period of two years. If, at the end of the probationary period, all conditions were met, the denomination/church can be considered for a five-year-approval period, renewable again with compliance. The document must also stipulate under what circumstances approvals can be rescinded immediately (such as doctrinal departures or tensions).
4. Under no circumstances should approval be given in a nation to establish a parallel Royal Rangers organization to that of the Chartering Steward. All Royal Rangers groups in a nation must work under one organizational umbrella and according to the same policies and procedures as outlined by the Chartering Steward and according to RRI practices and principles.
5. Denominations/churches using Royal Rangers are strictly forbidden from taking Royal Rangers to other denominations or churches inside or outside their nation. The expansion of Royal Rangers inside a nation is the prerogative of the Chartering Steward alone. The expansion of Royal Rangers across national borders is the responsibility of the Regional RRI Coordinators and Committees. Church leaders and missionaries (regardless of their sending nation) are urged to observe this policy.

SERVICES RENDERED BY ROYAL RANGERS INTERNATIONAL:

Royal Rangers International is strongly committed to supporting nations, through its Regional Committees, in four primary areas—curriculum, training, promotions, and camps. (In general, each Region will have individual policies and procedures in these areas.)

Curriculum: Royal Rangers International has created a start-up curriculum for nations introducing the ministry, called *RRI Global Curriculum*. Available in electronic format, the curriculum is intended only as a starting point. It can be adapted as needed to suit culture, language, academic calendars, etc. Approval to make these changes comes from RRI and must be in accord with the “Royal Rangers Vision, Mission, Values and Method” chart (attached; a full description of the chart is available in the official *Royal Rangers Leaders Manual*). As a matter of protocol, all requests to use the Royal Rangers trademark, curriculum and training programs, should be made in writing to the respective Regional RRI Coordinator. All requests will be answered in like fashion.

Training: Royal Rangers International has established minimal training standards that must be adhered to, called *RRI Training Guides*. It provides training guidelines in six areas:

1. Train the pastor/church leaders: This is a brief orientation and overview of the Royal Rangers ministry designed for pastors and church leaders. It is intended to equip elders with the knowledge needed in order to provide sufficient oversight of the ministry in the church.
2. Train the support staff: This training area prepares those who will serve the outpost (local Rangers group) in a support role.
3. Train the junior leader: This area of training is designed to prepare young people to serve as youth leaders in their local outpost and to encourage them to continue as leaders upon becoming adults.
4. Train the outpost leader: Events like the Leadership Training Academy and the National Rangers Ministry Camp are among the events in this area designed to prepare leadership to serve the local Royal Rangers outpost.
5. Train the organizational leader: This area of training will challenge leaders to serve in positions beyond the local church, to grow spiritually, to develop well-rounded ministry competencies, and to enhance their

leadership aptitudes. It consists of four tiers and is open to current and potential organizational leaders.

6. Train the trainer: This area of training is designed for those who wish to train others to minister in the local church.

After each training event, attendees are awarded patches and certificates as recognition for completing the required standards outlined in the guides. For that reason, at no time should a training event be called, say, National Rangers Ministry Camp, unless it meets the standards in the guide. In as much as possible, training patch designs should remain uniform.

Promotions: Promotions of the Royal Rangers ministry is primarily the responsibility of the national Royal Rangers office in each country. RRI, however, has prepared helpful promotional materials. Ministry consistency and quality are the primary elements that will engender favor among national church leaders, pastors, missionaries, potential leaders, parents and children.

Camps: RRI will assist and/or advise nations in camp ministry techniques and development such that Royal Rangers reaches its fullest potential as an adventure-mentoring camping program.

These services are available to the Charting Steward once the Chartering Steward Agreement has been signed.

THE INTERNATIONAL EXPANSION OF ROYAL RANGERS:

As a matter of process and procedure, nations should not take Royal Rangers to other countries, especially outside their region, without first securing proper approval. Such requests should be directed to the Regional Coordinator. Under no circumstances should a nation grant copyright approvals to another. This is the prerogative of RRI alone.

In no way does RRI wish to limit an individual's ability, or that of a nation, to obey the Great Commission and evangelize, equip and empower children and youth for Jesus Christ all around the world. In fact, RRI strongly encourages countries to remain or become involved in taking Royal Rangers to other nations. But RRI, through its Regional Committees, must serve as the "central nervous system" so that our work is done in a

manner consistent with New Testament missionary practices, and in such a way that human and financial resources are maximized.

As stated above, the expansion of Royal Rangers within a nation is the prerogative of the Chartering Steward, and the expansion of Royal Rangers across national boundaries is the prerogative of Royal Rangers International through its respective Regional Coordinators and Committees. Church leaders and/or missionary personnel, regardless of their home nation or sending organization, should work in coordination and in cooperation with RRI Council and Regional Committee policy and procedures and in accord with these *Cooperative Values and Practices*. By doing so, Royal Rangers all around the world will advance in a more systematic manner, at a much quicker pace, and with a spirit of purpose and unity.

ROYAL RANGERS: A MINISTRY FOR BOYS, OR FOR BOYS & GIRLS?

The Royal Rangers ministry in each region has an individual co-educational policy. For the purposes of international expansion, any individual or nation involved in missionary work must present the ministry in a manner in keeping with the respective regional policy. (For instance, when a nation with a ministry directed at *boys & girls* presents the ministry in a country or region where the ministry is just for *boys*, the ministry would be presented as a ministry to *boys*. The opposite would also hold true.)

THE ROLE OF THE NATIONAL ROYAL RANGERS MINISTRY:

The primary role of the national Royal Rangers ministry in any nation is to serve the local churches so that they are able to reach their ministry goals—primarily by making curriculum and all necessary materials available, training leaders, and promoting the ministry to inform pastors, recruit leaders, inspire parents and build membership. The national office must also network with other national ministries in the country to build the Body of Christ. It also has a great responsibility to protect the integrity of the curriculum, trademark, training standards, and overall effectiveness of the ministry.

To achieve these and other goals, the national office must structure itself properly. The National Director will serve as the director and should be elected/appointed and held accountable by the Pentecostal church organization serving as Chartering Steward according to their policies for national ministry directors. The National Director should be expected to pull together a team of leaders to serve in

capacities such as Assistant National Director, Training Coordinator, Promotions Coordinator, Curriculum Coordinator, Programs Coordinator, etc. The titles, portfolio, and number of positions are discretionary. However, the National Director should not work alone. It is recommended that as positions are created and filled, job descriptions be prepared and performance judged accordingly. All positions on all levels should be filled with people of integrity and Christ-like character. Succession of national leadership must be certain.

The National Director should also seek to finance the national Royal Rangers ministry operations. This can be done in many ways, but RRI recommends establishing a charter system/fee as the basis for underwriting the annual budget. Other sources of income may include church donations, grants, events, special fund-raisers, product sales, subsidy from church organizations, etc. Fiscal responsibility and accountability is expected of the national Royal Rangers ministry/Chartering Steward.

The national Royal Rangers ministry is also expected to actively cooperate with the Regional RRI Coordinator and Committee. Nations that participate in regional fellowship, curriculum development, training activities, events, missions projects, etc., are healthier and stronger as a result. Financial cooperation is also needed. Member nations are expected to pay \$100 per year, or 0.5% of the gross national Royal Rangers office income (whichever is greater) for the support of this international ministry. 100% of the funds will go to the RRI Council for trademark protection.

The bottom line is spiritual fruit is expected from Royal Rangers in each nation. Only in this way will the integrity of the ministry be protected. If the Chartering Steward does not see positive results from the National Director at the head of the Royal Rangers ministry, it is incumbent as overseers of God's church, to remove such people and replace them with individuals capable of leading in a manner that will produce spiritual results.

ROYAL RANGERS TRADEMARK, COPYRIGHT, AND PRODUCTS PROTECTION:

The Royal Rangers Emblem is a Registered Trademark, requiring express permission from the General Council of the Assemblies of God, Inc. (1445 N. Boonville Ave., Springfield, MO 65802) via Royal Rangers International (RRI) (1644 W. Lloyd St., Ozark, MO 65721) for use in printed or electronic formats (including websites) and on products anywhere outside the United States of America.

Once RRI, through its respective Regional Coordinators, has established an official Chartering Steward (an organization who accepts the charge to provide oversight and leadership to the Royal Rangers ministry within a nation), the Chartering Steward becomes the custodian of the trademark (but not the owner). All interested parties within that nation must seek approval from the Chartering Steward to use the Royal Rangers Emblem according to these guidelines and criteria.

This section of the *Cooperative Values and Practices* explains: 1) The acceptable legal uses of the trademark by the Chartering Steward in a nation; 2) The acceptable legal uses of the trademark by outposts officially recognized by the Chartering Steward; and 3) the criteria for using the Royal Rangers Emblem.

Acceptable legal uses of the official Royal Rangers logos and products by the Chartering Steward in a nation:

1. The Chartering Steward may produce the Royal Rangers Emblem, and products with the Royal Rangers Emblem, for sale and for profit within its own national boundaries and territories. It may NOT authorize third parties (inside or outside of the nation) to sell product with the Royal Rangers Emblem, except for chartered outposts and for those activities listed in the next section. The Regional Coordinator may allow exceptions whereby a Chartering Steward may sell products to the Chartering Steward of another nation, but direct marketing to individuals in other nations is prohibited. However, Royal Rangers attending events from outside the nation are free to purchase products while visiting. (The intent here is to protect a nation's ability to sell products inside its boundaries to support the national Royal Rangers ministry.)
2. The Chartering Steward may use the Royal Rangers Emblem on printed materials such as magazines and books per the criteria below.
3. The Chartering Steward may use the Royal Rangers Emblem on stationery, business cards and promotional brochures and fliers for professional and business use per the criteria below.
4. The Chartering Steward may use the Royal Rangers Emblem to market the ministry within the nation and to promote events per the criteria below.
5. The Chartering Steward may authorize chartered outposts to use the Royal Rangers Emblem on websites. Requests must be made by the outpost to the

Chartering Steward and renewed annually. Authorization must be limited to chartered outposts in good standing with the Chartering Steward for a period not to exceed one year, and may be renewed.

6. The Chartering Steward will have full access to the RRI curricular and training resources, but is not authorized to alter RRI materials, products, badges, etc. without advance written permission from Royal Rangers International. Nor does the Chartering Steward have the authority to allow outposts in its nation to alter these items. Written requests to reproduce or alter copyrighted materials must be received via postal service, FAX, or attached to an email by the respective Regional Coordinator; no phone requests are accepted. The Director of RRI and the respective Regional Coordinator must both authorize such approvals by mutual consent.

Acceptable legal uses of the trademark by outposts officially recognized by the Chartering Steward:

1. A chartered outpost may use the Royal Rangers Emblem on stationery, business cards, brochures and promotional flyers, provided they are a positive reflection on the ministry and the Chartering Steward, and provided the criteria below is met.
2. A chartered outpost may use the Royal Rangers Emblem for promotion of a dated event on products such as: programs, bulletins, brochures, flyers, posters, and newsletters provided the criteria below are met.
3. A chartered outpost is restricted from using the Royal Rangers Emblem and other ministry and training logos on salable items unless they are reproduced on an event-related, dated, salable item for one-time use only (such as t-shirts). The item must clearly identify the outpost (by number or church name). The product cannot be an ongoing salable item and can only be sold by the originating outpost at its own planned events (i.e., the outpost cannot prepare a salable item to sell at the national campout—sale of products are restricted to the outpost's own planned events).

Criteria: Use of the Royal Rangers Emblem and products is contingent on the following criteria being met.

1. The user must be chartered. No national organization, outside of the Chartering Steward, may use the Royal Rangers Emblem as described above. No outpost, except those chartered by the Chartering Steward, may use the Royal Rangers Emblem as described above.
2. The user must use the registered Royal Rangers Emblem in all instances—that is, the Emblem must bear the “®” symbol (except where local laws prohibit its use).
3. In books, magazines, and on websites the Chartering Steward must include the following: “Royal Rangers Emblem ® 1976 by The General Council of the Assemblies of God, Inc.; Springfield, Missouri 65802-1894. The Royal Rangers Emblem may not be reproduced, stored in a retrieval system, or transmitted in any form or by any means—electronically, mechanically, photocopies, recording, or otherwise—without prior written permission.” This wording is not necessary on stationery, business cards, brochures, flyers, or posters, provided the “®” symbol is on the Royal Rangers Emblem.
4. The Chartering Steward may use the Royal Rangers Emblem on its official website, with the legal wording in #3 (above), and offer salable products. Outposts, however, may not promote or sell items on their site. The use of the Royal Rangers Emblem on an outpost site is to be casual in nature and for ministry purposes only, and it must include the wording in #3 (above).
5. Copyright/legal information text (the wording in #3 above) must be placed on the same page location that the Royal Rangers Emblem appears, or just once at the bottom of the home page.
6. Websites with links to or advertisements offered by them or third parties of a questionable nature (such as adult sites, casinos, alcohol, tobacco products, etc.) will automatically lose the privilege of using the Royal Rangers Emblem.
7. The Chartering Steward is approved to use the Royal Rangers Emblem on its official site once it has signed the Chartering Steward Agreement.
8. Outposts must apply to use the Royal Rangers Emblem on their website from the Chartering Steward. Approvals are limited to one year and may be renewed. Outposts must disclose to the Chartering Steward the intended purpose of the site.

9. Failure to comply with all these conditions will automatically negate permission for the applicant to use the Royal Rangers Emblem, and the applicant will be held legally liable for breaking this trust.

CONCLUSION:

RRI desires to serve the growing number of nations using the Royal Rangers ministry. We are all part of the family of God with a desire to reach the lost and disciple the believer. In no way does RRI wish to control nations in this process. We trust the leading of the Holy Spirit and the leaders He raises up. Yet, mutual accountability is necessary to protect ourselves and the church we are called to lead. It is with that attitude and spirit with which the RRI Council and its Regional Committees wish to serve.

Brown, yellow, red, blue, white
