Assemblies of God Ministers Decry Anti-Prayer Ruling by Alabama Judge—An Oct. 29, 1997, permanent injunction issued by U.S. District Judge Ira DeMent in Alabama prohibits the governor, state attorney general, and state board of education from enforcing a 1993 state law permitting prayer in schools.

According to Governor Fob James, Jr., Judge DeMent, "threatened to hold in contempt of court all teachers and students in Alabama who offer public prayer to God while at school or even near a school." The ruling, Governor James noted, "cuts at the heart of all that is good in America and brings shame on our nation."

Alabama Attorney General Bill Pryor is challenging portions of DeMent's injunction. He has also called on Jay Sekulow, chief counsel of the American Center for Law and Justice, based in Virginia Beach, Va., to assist in appealing DeMent's injunction.

According to Religion News Service, Sekulow described DeMent's order as unconstitutional because it is "vague, over-reaching and flies in the face of numerous Supreme Court rulings."

Assemblies of God ministers across Alabama decried the injunction. The Rev. William Tyndall, pastor of First Assembly of God in Mobile, pointed out that judicial authorities like DeMent are "wrongly interpreting the Constitution. We all know that. But when you're dealing with a humanist mind, a secular mind, a God-hating mind, then I can understand why they cannot rightly interpret. We need to pray for them, but we also need to have strength to stand."

The injunction specifically targets schools in DeKalb County in response to a lawsuit there, but if undefeated it would create a precedent for other cases.

"It will probably be a landmark ruling," pointed out Pastor Charlie Glover of Calvary Temple in Anniston, "and other counties will follow suit if it is not defeated."

"There are people who are trying to erode the position that we've always maintained in this country," stated the Rev. Vaudie Lambert, district superintendent of the Assemblies of God in Alabama. "They are going under an interpretation of church/state separation that is moving away from our founding fathers' position."

The traditional interpretation of the Constitution allowed for school prayer through most of the United States' history. Pastor Ricky Holmes of Beth Haven Bible Church (Assemblies of God) can look back to his own elementary school years and recall the impact prayer had on his life in the public schools.

"Even though I didn't realize it then, I know now it had an effect on my life," Holmes said. "It had an effect on the way I acted in those classrooms and I had a little more respect for the teachers that I

don't see that students have anymore."

Lambert still can hear his sixth grade teacher beginning each day with a reading from Proverbs: "Every morning she made us recite from Proverbs, 'a good name is rather to be chosen than great riches or silver or gold.' That was indelibly stamped on my mind. And of course we always opened in prayer."

Some Christians might wonder if anything good could come from a judicial measure passed against prayer. But Holmes can identify at least one positive outcome.

"I think we're in for a revolution, not in a military sense, but a revolution spiritually in our prayer life with Christians bonding and coming together regardless of our denominational barriers. I'm seeing people come together now as a result of this that cross all the barriers of Christian denominationalism."

Holmes noted that court action has sparked a variety of protests.

"I heard this morning that one of the PTA organizations in the Florence area had always opened their PTA meetings with prayer. There's a controversy there because the meetings are held on school grounds. As a protest they have moved their meetings to one of the churches in town."

According to Holmes, some students are wearing pins that say they are for prayer in schools and several communities are having prayer vigils. "In Rainsville," he noted, "about 1,000 people met in one of the community centers on Thanksgiving Day to pray for this situation. It's not over by a long shot."

Holidays like Thanksgiving and Christmas only increase public awareness of prayer and other religious expression. The injunction's broad guidelines impact many traditional seasonal observances.

David Azbell, deputy press secretary to Governor James, explained to AG-NEWS that the governor's office is committed to supporting any schools that continue with traditional Christmas observances, such as the use of nativity scenes. He said that if anyone is found in contempt of court for violating the injunction, the full power of the governor's office will be behind them.

While future court battles will play a vital role in the direction religious expression will take in Alabama's schools, legal measures are not the sole means of bringing about change.

"You know, the Lord is going to help us," Lambert stressed. "We're going to stick by our guns here in Alabama. It's spiritual warfare. We can fight it in the courts, but we've got to go to the throne of grace and fight it too."

National Prayer Center—Operating the Assemblies of God's National Prayer Center is not easy, admits the Rev. Sandra Clopine, coordinator.

"Besides technological glitches that occur, we have callers who abuse our volunteers verbally, try to obstruct the phone lines, and generally cause confusion when possible," she said. "However, the vast majority call from a world of hurt and express appreciation for our being available to pray with them."

Since the center's founding in October 1994, more than 300,000 calls have come in. Reporting recently to the *Denominational Prayer Leaders Network*, Clopine said the center received more than 700 calls a day during the first 11 months of 1997. The National Prayer Center can be reached at 1-800-4-PRAYER (1-800-477-2937). Operating hours are Monday through Friday, 7 a.m. to 7 p.m., CST.

During the first weeks of January, the center was scheduled to add 5 new Satellite Prayer Centers to the 23 that are already active. The satellites are located across the country at churches and other ministries. When on-line, these additional volunteers have calls routed to them along with the volunteers at the National Prayer Center in Springfield, Mo.

"It's because of this volume of prayer," Clopine stressed, "that numbers of callers have prayed the sinner's prayer; others have been delivered from alcohol, drugs, pornography, and the occult; marriages have been restored; jobs have been provided; and dramatic healings have taken place. To God be the glory for it all!"
