The Students' Association of MacEwan University is situated in the centre of what we call the city of Edmonton, which is called Amiskwaciy Waskahikan or Beaver Hill House in Nehiyawewin. This is the traditional home of the Nehiyaw and Michi, and meeting place for many Indigenous peoples including the Nakawe, Siksika, Nakota Sioux and other nations.

Item 2: Approvals. 2.1, we have a motion. Councilor Ruiz.
