C Thank you. Item one, treaty six land recognition. We would like to acknowledge that this meeting of the Students' Association of MacEwan University is taking place on the traditional territories of the peoples of the treaty six region in central Alberta.

The Students' Association of MacEwan University is situated in the centre of what we call the city of Edmonton, which is called Amiskwaciy Waskahikan or Beaver Hill House in Nehiyawewin (Cree). This is the traditional home of the Nehiyaw (Cree) and Michif (Métis), and meeting place for many Indigenous peoples including the Nakawe (Saulteaux), Siksika (Blackfoot), Nakota Sioux (Stoney) and other nations.

Before we move on to item 2, approvals, do we have anyone calling in today or...

- C Okay. Councillor Drummond can you hear me okay?
- CDR Hi.
- C Hi. I'm going to take that as a yes. So if you can't hear just speak up and we'll do something about it. Item 2, approvals, 2.1 we have a motion. Anyone care to make that motion? Councillor Strayer?
- CST Move to approve the agenda for May 15th 2019.
- C Thank you councillor. And a second? Vice President, thank you. It has been moved and seconded to approve the agenda for May 15th 2019. Is there any debate? The question is on the adoption of the motion to approve the agenda for May 15th 2019. All those in favour? Thank you. And opposed? Motion carries.

Item 2.2 we have another motion. Councillor Ruiz.

CR Thank you Chair [?] I move to approve the minutes of April 17th 2019.

C Thank you councillor, and a second? Councillor Yanish, thank you. It has been moved and seconded to approve the minutes of April 17th 2019. Is there any debate? Question is on the adoption of the motion to approve the minutes of April 17th 2019, all those in favour? Thank you. And opposed? Motion carries.

Item three, we have a presentation. I understand the Vice President of Academic is going to introduce our guest so take it away.

- VPA Great. So we do have a presentation on the annual giving campaign today and we're going to get right into it. But on our left here we have Frankie who's the director of student financial aid and to her right will be Michelle, the senior development officer. And I believe I got the titles reversed.
- M No that's it. Yes.
- VPA Oh that's correct? Okay, awesome. So yeah, Michelle, student development officer of the new alumni project that's going on. So, yeah. Without further ado, take it away.
- M Awesome. Thank you very much everyone for having myself and Frankie here today to speak to you guys. Like Shawn [?] has said, Frankie's from student financial aid, I'm from alumni and development. I don't know if many of you guys have heard of that department but we're located at USC in building six I believe. Or building ten or whichever that building is.

So we're here today because we think it's important to talk to you guys about some of the things that we're doing to help students. So right now we're launching our annual



giving campaign. So what that means is we are going in front of as many staff faculty members as we can to tell them about some of our initiatives for this year for fundraising and what they can do to help support it.

So this year we are asking our staff and faculty members to consider supporting our scholarships, awards and bursaries program which affects all students. And so yes, thank you very much for having us here to speak about that.

FB Thank you for the kind introduction. So as Shawn said, my name's Frankie Billingsley and I'm the director of student financial aid. And it's been really awesome to talk to staff and faculty members at MacEwan about the fact that student financial aid has only existed at MacEwan since August of 2017. And a lot of people don't know that and then the question I get is, well why did you even come to be?

I'm pretty sure that MacEwan University was the last post-secondary institution in the country to have dedicated resources to helping students figure out how they're going to navigate their financial journey through school.

In addition to that, we have internal audit staff at the university who choose different areas to audit throughout the year. Financial aid was chosen for an audit four years ago, and their report took over 12 months and it was not very complementary. And one of the things that they said was, you have money advising all over campus and you need to consolidate into one area so that students find it easier to figure out where to go.

We had loans in one area, we had grants in one area, we had scholarships in another area. And they said, you know what, bring it all together. So we did that. And then they needed somebody to run it and they asked me to do that and I was like, okay.

One of the things our office is responsible for is for identifying funding gaps in the student experience. And so I've been working really closely with Michelle's team and here's some statistics that I'm sharing with faculty and staff around the campus that I think that they have found really startling.

One of them is, currently Canadian students are carrying 28 billion dollars in student loan debt. I don't think people really realise that. This does not include consumer debt. This is just student loan debt. I think it's also fascinating for people to know that MacEwan students are accessing the student loan program 7% more frequently than the national average. The national average is 35%. 42% of MacEwan students are accessing the student loan program.

And I can assure you, in the 25 years that I've spent working with you people and people of your age group, if you have a way to pay for your education, you're not going to get a loan. If you don't, you're going to get a loan. 42% of our students are on a loan. That is staggering to me.

The other two statistics, in my world we have common definitions that we use. Scholarships are for outstanding academic achievement, bursaries are based on financial need and awards are in the middle. Awards can be based on community involvement, volunteerism, leadership. This past fall semester we had over 2000



students who applied for a bursary and my office was only able to award 388. Over 75% of students at MacEwan who demonstrated financial need went without money.

These are the kinds of statistics that I'm showing, that we are showing faculty and staff around the university because we're trying to increase staff participation in philanthropy and giving. So these statistics inform the first strategic priority for fundraising which is our student retention bursaries.

Research shows that one of the reasons that students don't graduate is because of financial duress. I personally don't want to see one student leave MacEwan because they can't afford to be here. That to me is unacceptable. But I think that's happening. And research also shows that if financial stress is going to manifest itself while someone is a post-secondary student, it's not going to happen in the first year, it's going to happen in the second, third or fourth. Which is why we are focussing on retention.

On the complete opposite end of the spectrum, I think we were the last post-secondary institution in the country to have a robust, equitable entrance scholarship program. So starting this fall, students who enter into MacEwan, into a degree program with a certain high school average, they will receive a scholarship offer in their admission letter.

And I can tell you when I presented this to student council three years ago, every member of the council was like, man I wish that was in place when I started, right? It's just a really great... I wish I had more money because I would extend that opportunity out to diploma students and certificate students as well. But right now I only have enough money for degree students.

And I'll tell you, it's been really awesome for us to talk to staff and faculty about these things because I feel really blessed that I ended up in this role. Because my brothers and I wouldn't have been able to try post-secondary education if it wasn't for an entrance scholarship program. Like, my parents couldn't afford for us to go, we didn't qualify for student loans at the time.

So just think about that for a second. Think about a really strong, academic student out of grade 12, that wouldn't even be able to try school if it wasn't for that. Right? And with retention bursaries, by the time I was in year three, my parents could only afford one bus pass. And all of my brothers were also scholars as well so we had to figure out how the three of us were going to get to school and keep our scholarships.

So my brother had the largest one so he scheduled his courses on Monday, Wednesday, Friday. My other brother and I scheduled Tuesday, Thursday. And so, think about that. I missed 50% of my classes in one of my semesters just because I couldn't afford to get there.

So I tell faculty when we present to them, do you realise that some of your students can't actually get to school? Do you realise that when they're here they might be hungry? They might be worried about paying for their rent? I think you all know exactly what I'm talking about because you see these students, you've talked to these students who are financially stressed.



And one of the great things about talking to everybody who works at MacEwan... We got a lot of people who work in places that they never interact with students. We got human resources, we got IT, and I say to them, regardless of where you work, none of us would be here if it wasn't for you. So this is a good reminder that it's all about the students.

M Thank you Frankie. So you know, what we're really trying to tell our donors is, we want them to be engaged with us, to help support our scholarships, awards and bursaries program, and to help you guys, the students here at MacEwan. So that you guys can succeed and move forward with your careers and whatever your dreams are, right?

I think it's really cool that MacEwan is able to embrace so many of these things like smaller class sizes, diversity, inclusion, optimism and change, because we are a downtown university. Because we are smaller, we're more of a tight-knit community. We're able to offer these things and help elevate our students' success here as well as our student experience.

We want to try and find ways to inspire donors to give and one way to do that is by encouraging our internal people to start giving and to start participating. Because imagine the impact of a message that we can give them if we can tell them that we have a 100% internal staff participating in our initiatives.

- FB And they ask all the time. Like every donor meeting that I've been, whether the donor is talking about \$1,000, 25,000, 425, it doesn't matter. At some point in the conversation they say, well what's MacEwan doing? So just so you all know, before this campaign started we had less than 1% staff participation. Less than 1%. Four months later we're at 3%. Hey, it's not bad. We've doubled, that's great. But just so you know, the industry standard is 10%. So we got a long way to go but hopefully the strides we've gained this year, we're on an upswing.
- M For sure. So alumni and development, if you don't know who we are, we work with donors to help find money for our students, to help find money to build our hall, to help find money to build any future projects and buildings that might come through MacEwan.

Through this campaign we are trying to encourage our donors to be more engaged with us, encourage our staff and faculty members to help us make an impact. And through the campaign we want to raise awareness about some of the university needs, strengthen the culture of philanthropy here at MacEwan because it is quite low. But also to increase the staff participation in general.

Our role here is to help our donors connect with MacEwan and their priorities, help them fulfil their philanthropic goals, and help them figure out how they can invest their money in our students here at MacEwan so that they can see our students succeed. Because really, you guys are our future, right?

So what are we telling our staff and faculty members to do? We are asking them to consider giving to our scholarships, awards and bursaries program by just signing up for a payroll deduction. If everyone of them were able to give a minimum of \$5 per bi-



weekly pay period, we would raise over \$300,000 towards bursaries, which is double the amount that we would have given out last year.

So it's a small amount that we're asking for from our staff and faculty members but we're really making the most important is the participation.

We do have a donor giving website. If you have not had a chance to take a look at it, we have lots of donor stories, lots of student stories. If you know of alumni or alumni stories that you can share with us, we'd be more than happy to work with them to maybe feature them on our website as well. We're always trying to engage with our alumni so if there are opportunities there we invite you to reach out to us and we can work together on that.

I guess [unclear] you don't really need to know but... That's pretty much all that I have right now. Yes, it's really easy for them to sign up, we invite them to go to our website. There's tonnes of things to support other than these two priorities. If you don't know about our scholarships, awards and bursaries program please visit our website, there's tonnes of information there.

And yes, we really just wanted to engage you guys, let you guys know what we're doing because I remember when I was a student, I didn't realise... Well, I guess I didn't really understand where our scholarships, awards and bursaries came from. And I don't know if a lot of students know that those things come from donors. They come from people who have money that they want to spend to help invest in our students. So I don't know if Frankie has anything else to add.

FB Yes, I think it's really awesome for you to know what we're talking about with faculty and staff related to student initiatives. And this is impacting you and all of your colleagues and classes. And for me, like I said, my goal is, I don't want to have one MacEwan student leave school because they can't afford to be here.

We're starting a new program where we're trying to identify students who are at their maximum student loan lifetime limit. Which, for those of you... Who's on a student loan? One person. Two. That's amazing out of this many students considering 42% of students are in it.

But the lifetime maximum is \$75 000 and it's staggering to me how many MacEwan students are at that limit. And we need to find out where they're at in their program, how much longer do you have to go, how are you going to finance that? Because I want people to finish. You know, and thanks to you, the students' association does fund a couple of different really awesome pots of money.

We have an emergency bursary about \$15,000 and just so you know, some of the people who have received that funding... We had a student whose house burned down. We had a student whose dad had a stroke and they had to drop some classes because



they had to be the primary caregiver. We had a student who fled a domestic violence situation.

Like, we've got students that... Life happens. And school is just one part of what you're doing. And so if our office can help, awesome. And if we can get staff to participate to give me more money, that's even better. Does anyone have any questions at all?

UF Most organisations that ask for money have qualified for like a gift matching program. Do you know if MacEwan has anything like that? So if you go to a company and you say, hey, would you like to donate? What if through some portal, they can match the donations they make? Does it mean that we, as an organisation [unclear]?

- M Yes. So we can work with people who work at other companies that offer matching programs. MacEwan currently doesn't do the matching. I know we've done it in the past for certain projects and certain initiatives. Right now we don't. But if you do know of people outside of the MacEwan community that really want to help MacEwan students and they do want to donate to something, and if their organisation has that matching opportunity then we can definitely work with that for sure.
- FB We're in a tough situation there because it's publicly funded money. So although it would be going to students, the core business of a university is teaching. Right? So making sure that that academic mission is taken care of first is the most important. And I would also say that until we kind of know what's happening with the current government, budgets are tight. So a matching program wouldn't be something that there would be an appetite for right now for sure. Maybe in flusher times, but not right now.
- M In [unclear] to that, I'm not sure if you guys heard of our pass it on campaign. Has anyone heard of our pass it on campaign? Okay, so we started it last year and essentially it's to help engage our students who are becoming alumni, helping them take their first step into philanthropy here at MacEwan.

And so last year what we were asking our new alumni was to donate a minimum of \$18 and they received a special silver tassel that they got to wear as they crossed the stage and that was a donation to our alumni legacy fund and that legacy fund will provide a scholarship to the future students here at MacEwan.

This year we are happy to say that our alumni office will be doing a matching type program for this campaign.

- FB Pretty riveting stuff, huh? It's been pretty awesome. How many presentations have we done? We've probably done close to 15.
- M 15 or something. Yes. As a team I think we're pretty much almost done. We have a few more departments left but MacEwan's a big campus.
- UF I just have a quick question. You mentioned alumni can share their stories. Is there opportunities for current students or potentially anonymously or get involved too with helping to spread awareness about these campaigns?



And then two, if students are having trouble navigating applying for scholarships or bursaries, it's probably fairly comprehensive on the website, I've done it [?]. But if they have troubles are they able to access you guys in your office in [unclear]?

- M Definitely. For sure.
- FB Yes. So with the latter part, if people are having troubles with anything related to money, the financial aid advisors are available 8:30 to 4:30 downstairs. Yes. If you're facing the registrars office their on the far right. They're right beside fees. We thought it made sense to have all the money together so finance and fees are together. And then with...

M Yes, with the alumni stories we do have an alumni office [?] too. So I'm on the development side, we have an alumni side of two people. But if you do have interesting stories that you want to feature or you want to share, connect with us and we can chat further on that. And there are lots of stories online so we can [unclear].

I will be sending out the presentation and my email will be there so if you guys have additional questions or questions in the future I'm more than happy to work with you guys through those.

- FB Yes.
- CR I don't really have a question but I wanted to say that it's really great that after, as you said, like you you came [unclear] in three years. [Unclear] that program now that you're giving to first year, it's really great and I'm hoping that that will make a big difference for people to try out the MacEwan experience. So I wanted to congratulate you on your achievement.
- FB Oh thank you. It's been really great going around campus and talking to people about this. I can assure you that especially when I'm talking to people that teach here, when we leave the room, I know that they've been impacted by things that we've said. Because I don't think that they really think about the fact that you all have your own lives and you all have stress.

I think they get it but when they have these staggering statistics in front of them it really hits them and it's impactful for them. And that's been one of the best things for me, is I know that every time we leave a room that people have learned something and they are thinking about your experience in a different way.

And I think the thing that people love about MacEwan is we are about students. And people really love teaching and they want to make sure that the student experience is paramount. So if they can assist with that I think they want to do that. So I think we're going to see some huge strides over the next little while. This is just the beginning. I think we have a 50 year campaign coming and I think scholarships, awards and bursaries are going to be a part of that.

But thank you very much. It's been a really great experience because this is a completely different way of asking people on campus for money and it's not easy to do that. But you know what's easy to talk about? Is you. It is really easy to talk about



students and what they're going through and I have the data to support why we're doing what we're doing. So it's really hard to argue with that. So it's been pretty awesome but thanks. And thank you for the time.

He made it clear at GFC. And he advocated for SAMU so that's nice.

I met with the Dean of Nursing the next day on the Friday, Dean of Nursing gave me a lot of feedback [unclear] on my goals which was awesome.

Student research [unclear] that meeting was on the Monday. Basically I've been to Student research day three years in a row so kind of trying to deal with some criticisms and feedback that can make me better, but also it's mostly really good so I was congratulated on how well it's done. But there's some ideas about moving things to be bigger and trying to figure out scheduling and rooms.

CS Yes I did have a quick thing that we had discussed in our audit committee that wasn't part of that report. And it was just that we are also looking at expanding the scope of the audit committee training to provide more insight into what we should know when we review our reports as well as review regularly our policies and procedures relevant to the audit committee so that we can better address that part of our mandate.

So that is part of our mandate and we're not currently, or not that I know we've ever really talked about those policies and procedures and really reviewed them. So that might be something that the audit committee really looks to do and really doesn't fill that part of our mandate. And that's all, thank you.

- CS Thank you chair. I just have a couple of short questions. The first would be directed at the Vice President Academic and just asking, they used the acronym USRI and I was just wondering what that stood for?
- C Thank you councillor. Vice President?

VPA Sure. The USRI is the Undergraduate Students Research Initiative. So it's like whether you're disseminating at a conference or you're doing research yourself, you can apply for grants for that. And, it's funny, they're usually not all taken up. So there's a big... Some of my [unclear] students doing research and students should probably know more about it because they never use all their funds. But it is there for both dissemination and for research to support undergraduate students doing research.

I think, if I'm not mistaken, one or two councillors are or have applied for that grant. So some people are kind of familiar with that.

- C Thank you Vice President. Councillor Stewart?
- CS I guess a follow up would be, VPA did mention that maybe more students should know about this. Is there a role within SAMU and our [unclear] to help students know about some of these campaigns and some of these initiatives?
- C Thank you councillor. Vice President?
- VPA Definitely. This is one of the things that information campaigns are critical and marketing is critical to actually have students be aware of them. There's frankly a few things that are underused in terms of grants or even like in terms of committee opportunities for students. And the more visible SAMU is the better.

So as far as the logistics of that, will be worked out closer to July, August. And especially that one in particular is not in the top ten priorities. But marketing could go a long way with those things, I think they're not nearly well known enough. And awareness needs to brought to them.

- C Thank you. Councillor Stewart?
- CS Thank you chair. I also just have a quick question for the Vice President of Student Life. They mentioned in their report attending the Social Innovation Institute advisory council. I was just curious if they could elaborate more on social innovation and maybe what that advisory council role actually is. To me the name... I'm not really sure what that sometimes means. So what the role of that advisory council is and what they're hoping to do with social innovation. Thank you chair.
- C Thank you councillor. Vice President?
- VPSL Yes. So the social innovation institute works in partnership and kind of overseas roundhouse. I'm not 100% clear on how they interact together but I know the Social Innovation Institute is working with Roundhouse to see how they can become more engaged with the community, particularly looking at getting more involved with affordable housing for low income folks and for their outreach to marginalised communities. I hope that answers your question, kind of.
- C Thank you Vice President. Councillor Stewart?
- CS A quick follow up would be, I'm guessing those initiatives are focused on student... Those are projects focused on the student community not just the broader community?

C Thank you Councillor Stewart, Vice President?

- VPSL Yes. It is kind of an integration between the student community and the broader community. I believe the Social Innovation Institute is trying to engage some external stakeholders to get more involved in Roundhouse. So that's definitely a piece of that. But they are still central to the student community.
- C Thank you Vice President. Councillor Stewart?

- CST Thank you chair. So I'm going to try and word this without being offensive to as many people as possible. I recognise this is going to be a rather contentious topic and people could take this potentially the wrong way. My intention with this question isn't to offend current councillors who sit on this committee. This is in regards to leadership and engagement.

So I had a look at the minutes from the past two meetings. The TOR says that the leadership and engagement is supposed to meet once every month. In the past seven months it met twice. That's not an indictment on the current councillors that are on that, I think it's a matter of leadership, that's on the committee.

CST Thank you, that appeases me. To follow up on that, within the work plan, they talk about councillor day. Councillor days has mandated within the roles and responsibilities of student councillors and the executive. There's no specific outline within the roles and responsibilities though within the workplan of leadership and engagement, does say to meet... Sorry, to create councillor days monthly.



Within the TOR, it also says, to create a schedule for student councillors office hours. I'm curious if that's part of your mandate for the future and I think that would also pertain to the VP of student life to a certain extent.

- P I feel as though we should meet one on one to discuss this further because I don't feel as though we can really figure something out in this specific setting. Thank you chair.
- C Thank you President. I think we shed some light on that issue. Thank you councillor. Councillor Strayer, anything further?
- CST One last thing. This is for VP of Academic. I'm interested in details of GFC if you can do that for me?
- VPA Sure.
- C Sorry, Vice President. Council meetings aren't a conversation. So if you direct the question to me please and then I will cede the floor to the appropriate individual. So thank you councillor. Vice President?

- VPA But thank you chair. Appreciate it. There's a lot so I'm going to maybe start with the most important things. Because GFC is naturally a really long meeting with a lot of topics. And there was two like back to back. Both made their way into my report because they were on the [unclear] typically they're a whole month apart.

So it's an interesting [unclear] if I go over the most recent one because the topics addressed in the last one were on the agenda that Jackie [?] would have seen and probably would have brought to your attention. Mostly the things are on faculty [unclear] so I'll just touch on the most recent GFC.

The best thing that I can see in student interest that has come out of that is the OER fellowships that were mentioned by the provost so we already went over those. But essentially the details of that is that there's five grand for five different pilot projects in five different programs. And they're trying to [unclear] to see how much they're going to cost as a first test. So what the provost has said, has committed to, is that 25K as a total will never change.

So let's say some of these OER programs take less than five grand. Let's say they all take 2.5. Then you can double the amount because the total amount, the total of 25 grand is never going to go down. Even if these projects cost less, they won't do less projects, it will be more projects that each process individually [?].

So you have this 25 grand going forward, to stay annually, to put forward programs like this to get OERs working. To me, because of the courses they're picking that are heavily used by students, it's going to save students a lot of money [unclear] a really



fantastic initiative. So we're going to kind of monitor it to see what it costs and look at it as an experiment.

Another thing I really liked about the meeting was a discussion about how to [unclear] additions to our outbound [?] funding. So outbound experiential opportunities, whether they are credited or non-credited the [unclear] has said. So whether they're clubs or classes. Are going to be top of my first priorities when it comes to funding and they have made there way to the strategic plan.

So these kinds of things have made their way in [unclear] to the top eight goals. I think that's fantastic because there's lots of non-credit and credit opportunities for students [unclear] which is awesome.

Also MacEwan now has a chem major so I'm not sure if it's starting... I believe in about 19, 20 or 2021. They did pass a chemistry major. It doubles as a professional entry certification. I thought that was excellent and it passed without any questions, it was really easy.

We also voted on the strategic plan for the next five years. Or sorry, no we talked about the goal we take in September. Because there's some final stakeholder consultation that has to be done. It was really cool to see the next five years strategic plan in being so in line with the interests of students.

The focus on small class sizes while still developing [unclear] while not reducing teaching load on professors, is really interesting to see because you could see, you know, a five year strategic plan that focuses on research going a bad way where students aren't prioritised any more. And I thought that was really, really excellent.

Lastly, there's a bit of worry about lean [?] times. They're talking about [unclear] but well frankly it was discussed that they were a bit nervous about that which came up. And the last thing that I would say is that the provost did approach me about the new GFC structure.

So some of you are aware the PSLA has changed somewhat with the government structure of the university being required to change in response to that. So the post-secondary learning act defines what our government structure is, it's moving to a bi-[unclear] system which means all the seats, all the membership, all the committees are in potential risk of changing. Either the seats are being dissolved or new ones being created. There's a lot of flux. Which means student seats are at risk.

Jackie I believe covered this last time, that all student seats are being removed from GFC except for two which would be the one allocated to me and the one allocated to the President of SAMU. So the provost did approach me about his interest in having maybe a few more student seats there. Making sure student seats are kept in other sub-committees.

As well as changing the term [unclear] GFC seats. That one's complicated but basically Riley [?] and I can't vote on GFC until September even though we joined last week. And the provost is concerned about this over the summer in case there is a controversial



vote that has students interests on the line. Whether or not students can vote during those summer months.

Because you can see kind of what he's saying. You can see potentially if there's a controversial vote that effected students they could slot it in and students not get a vote during the summer. So maybe changing that term limit or adapting it so that the students term can start a different time than faculty terms would help and then we could vote over the summer.

Because Riley and I... There's was nothing contentious that came up that we would have had to vote on but Riley and I do want [unclear]. So what. Yes. But [unclear] is awesome, OER funding is awesome, chem major, [unclear] and student seats. That's the gist of it.

C Thank you Vice President. Councillor Strayer I'll get back to you. Just a couple of things councillors just to be reminded of. We refer to each other by our titles at this table and secondly, you know, many of you likely aren't familiar with the student council meetings policy, however, I am. And we do have restrictions on questions and answers in question period.
