Students' Council Report

President

November 2020

Greetings councilors,

Below is my report on my work as President between October 21st and November 16th, 2020.

Dedicated Advocacy

Alberta 2030 System Review: Student Roundtable

Along with representatives from all other post-secondary student associations in Alberta, I participated in a roundtable hosted by facilitators from McKinsey & Co who discussed aspects of the AB2030 review with us. There were several student roundtables that week, making for roughly 15 representatives per meeting. Although the sessions were a bit short at one hour, I was able to speak to some aspects of the review. Subjects of note include tuition deregulation, changes to governance, and the role of industry in informing curriculum.

Tuition and MNIFs Increase Negotiations

SAMU Executive Committee (EC) met with some of MacEwan's central administration for consultation sessions on tuition and fee increases. We met more times than the required minimum amount, and had robust discussions on the subject. The exact tuition and MNIF change for 2021/22 will be known publicly soon, when it is approved at the Board of Governors.

Canadian Alliance of Student Associations (CASA) Advocacy Training and Scheduling Vice President External Ruan Bouwer and I attended CASA's training and have been scheduled for advocacy meetings with Members of Parliament for CASA's digital advocacy month.

Council of Alberta University Students (CAUS) Counterparts Conference CAUS' Virtual Counterparts Conference and Advocacy Week are underway, and I have attended 1/3 days of sessions. I am booked to meet with two Ministers and one MLA this week, and have also found the programming of Counterparts to be very valuable so far.

Edmonton Student Alliance (ESA) Meeting

ESA met at the end of October to cover a number of items including ratification of our priorities document, approval on proceeding with ESA's strategic plan, consultation on municipal advocacy plans especially as they pertain to the 2021 election, and final discussion ahead of the ESA City Councilor Forum.

Retreat: COVID Advocacy Points for MacEwan

EC has compiled a list of COVID-specific topics that impact students at MacEwan as a reference for the official position of SAMU on these persistent issues. In doing so, we also have identified some areas in which further advocacy is needed, to draw attention to important unresolved items.

Commitment to Sustainability

Annual Mid-Year Retreat: Planning for Winter Term & Succession

EC has established plans and timelines for the remainder of our terms and succession. Around this time of year, it is helpful to take a step back and evaluate how much time is left in one's term, what remains to be accomplished, and reconcile the two by slotting objectives into timeframes. Further, transition begins at the start of April, so we are already considering how we can have a successful transition for the next iteration of EC.

Virtual Students' Council Training

EC attended and led portions of SAMU Students' Council (SC) Training where we had both elected councilors and prospective appointee councilors undergo training on Roberts' Rules, SAMU as an organization, the role of a councilor, and much more.

Relations with our Community

ESA City Councilor Virtual Forum

ESA hosted the second annual City Councilor Forum, but this time over Zoom instead of at MacEwan. The forum went exceedingly well, and we were able to discuss a wide range of items with the four councilors in attendance. Topics included youth participation in municipal politics, the brain drain issue, municipal election 2021, and the Edmonton City Plan, among others. Much of what was garnered at this event will inform ESA's strategy going forward.

Alberta 2030 System Review: General Faculties Council (GFC) Session MacEwan's GFC held a consultation discussion about AB2030, in which we discussed the merits of bicamerality and whether it should be upheld at post-secondary institutions in Alberta, as it relates to the AB2030 process.

Alberta Union of Provincial Employees (AUPE) & Alberta Federation of Labour (AFL) – Statement of Support SAMU released a statement on Twitter in support of the AUPE and AFL's recent attempts to draw attention to the extreme nature of the Government of Alberta's budget reductions, the most applicable in our case being the grant reductions in post-secondary education.

Installation of President Trimbee

I took part in the installation ceremony for MacEwan's sixth President and Vice Chancellor, Dr. Annette Trimbee. A video message of me on behalf of SAMU EC was delivered at the event, and I watched remotely since the in-person portion of the event was cancelled.

Greg Christenson - Tour of SAMU Building

I met Greg Christenson of Christenson Communities, the namesake of MacEwan's Sports & Wellness building, and accompanied him on a brief tour of the SAMU building.

Stewardship of Resources

Retreat: Revenue Diversification: Long-Term Planning SAMU EC and General Manager (GM) held preliminary discussions for future revenue diversification and what forms it may take.

Integration of the SAMU Building

Retreat: Building Analysis & Comparisons

SAMU EC and GM analyzed the SAMU building to begin formulating ideas about future opportunities enabled by the new building. Our discussion included comparison to existing students' association buildings in Alberta, and the kinds of amenities they offered.

Connect to Students

MacEwan Virtual Open House - SAMU "Booth"

I helped present on SAMU for virtual equivalent of a "booth" at the MacEwan Open House and, along with the rest of EC, spoke to some prospective future MacEwan students.

Winter Semester Strategic Marketing - Planning Session

SAMU EC met with our Department of Marketing and Communications to create a timeline of events which will include marketing components for the winter semester, and to give enough notice and up-front information to allow these plans to be executed successfully.

Closing Remarks

On this side of reading week, fall semester seems quite a bit closer to being done; several projects are wrapping up while we look ahead & plan for winter semester. EC's mid-year planning over the reading break was a much-needed chance to think in a long-term fashion about our goals for the coming months, and it's been helpful in orienting our direction as a team.

It's exciting to have a new group of Students' Councilors, and I hope that you will get a lot out of this experience! It is what you make it, and it can be very rewarding & certainly is interesting. If one of the new councilors ever would like information from an executive or wants to discuss SC matters with us, our doors are always open, at least virtually in the meantime. Alternatively, you can discuss these topics with other councilors as well.

Lastly, I think the current numbers warrant attention being drawn to the active case count for COVID-19 in Alberta, since we've now surpassed 10,000 active cases, almost half of which are in Edmonton. I hope that students will treat this crisis with a level of seriousness so that everyone does their part in curbing the spread of the pandemic.

Please find my report below detailing events that occurred between October 19th and November 13th.

Dedicated Advocacy

Alberta 2030 Bicameral system GFC Consultation

President Dr. Trimbee called a meeting to discuss bicameralism at MacEwan to inform their letter addressing part of the Alberta 2030 Post-secondary review. I and our President as well as Myles Dykes participated actively in the meeting and helped with the discussion making our student presence known.

GFC Standing Committee Meetings

The Academic planning and quality assurance committee, the academic standards curriculum and calendar committee, the committee on teaching and learning and committee on scholarly activity council of student affairs all met and I attended or was briefed on whom was elected to be the faculty co-chair from the GFC representatives and scholarly activity

MacEwan Academic Advising Steering Committee(MAASC) Meeting

I attended a MAASC meeting where they discussed the new website updates to be ready for open house and faculty advising updates and concerns extensively.

Provost Monthly Meeting

In my meeting with Dr. Monk we discussed MacEwan's covid protocols and reporting, tuition/budget thoughts and concerns as well as the AB 2030 review.

Tuition and Mandatory Non-Instructional Fees (MNIFS) Consultation Meetings

We got to meet with MacEwan about the MNIF's and our views on their projections and ideas for them as well as for tuition increases that were impacted by the governments cuts to grants and fee increase allowance.

General Faculties Council Executive Committee Meeting (GFC EC)

GFC EC had their meeting to discuss the agenda for the next GFC meeting and discussions the rescission of the outdated Student Discipline policy, consultation for the Honorary Doctorates policy and the potential for GFC to see the annual report.

AVP Students Hiring Committee Meetings

I attended the SAMU consultation meeting, the town hall event and another planning meeting where we got to discuss the attributes we are looking for in a new AVP Students. We also went over the marketing materials for the advertisements about the position.

Relations with our Community

International Day of Action Against Contract Cheating (IDoAACC)

Dr. Paul Sopcak with the Academic integrity office had invited me to join him to take part in Canada's part of the twenty-hour live stream. We had a few minutes to share our experiences with using the restorative resolution approach to address academic integrity violations at MacEwan.

Open Educational Resources (OER) Staff Survey Meeting

I got to meet with the OER librarians to discuss the staff survey with questions on Zero cost course material usage and understanding with faculty.

Stewardship of Resources

Animal Research Ethics Board (AREB) Meeting

At our AREB Meeting we had a short info presentation on zebrafish tank stimuli discussed and reviewed a research protocol on the zebrafish research.

Information Technology Management Committee (ITMC) Meeting

At the ITMC meeting we discussed most notably the winter scheduling plans and some of the changes that were being made/reorganized to adjust to a mostly online semester again but aiming for 25% in person and/or hybrid options. We also discussed the LMS, e-proctoring system and that Respondus was no longer being explored but Proctorio would be considered and talked about the adobe licenses for students/on campus.

Proctorio Demonstration

I got to attend a live Proctorio demonstration and ask some questions about the functionality of the service. It seems like it has a wide range of features some of which could be promising for facilitating online exams. We were careful to ask about its accessibility, that it is not a biased system/have discriminatory flagging and that students' privacy remains protected and secure but we will have to continue to think about these things if it is further explored or tested.

Commitment to sustainability

Students Council Training

We had our fall council training over zoom which featured a mental health and unconscious bias training workshop and other governance training sessions that I think went well. It was nice to hear from you all about how it went and how it could improve and to meet some of the people interested in joining council too. Despite our small council right now I remain optimistic about the people we will or hope to appoint and encourage you to continue reaching out to students who might be interested.

Stars and Wishes

We had our third stars and wishes meeting where we reviewed some of our values and our performance since our last meeting with one another which provided another great opportunity to connect.

Executive Committee Midyear Retreat

Getting to go on this retreat was such a blessing since we got to do some team building and have some much-needed conversations around SAMU's long term vision, opinions, and transition planning. I am so thankful for my fellow executive team!

Integration of the SAMU Building

I have nothing new to report here besides working from the office continues to go smoothly and lots of safety precautions in action. Remember to wear your mask and stick to physical distances to keep you and others safe with the rising numbers.

Hello Councillors,

In this report I will detail my activities between October 16th and November 13th.

For those who are not familiar with some of the advocacy-related acronyms:

- CASA is the Canadian Alliance of Student Associations, our federal advocacy umbrella organization with 23 total members.
- CAUS is the Council of Alberta University Students, our provincial advocacy umbrella organization with 6 total members.
- ESA is the Edmonton Student Alliance, our municipal advocacy umbrella organization with 8 total members.

Federal Advocacy

CASA Virtual Mock Advocacy Meeting (Oct. 30)

Sean and I attended CASA's mock advocacy meeting in preparation for federal advocacy month, which ran into some technical difficulties. These difficulties only solidified my confidence in SAMU's external team to improvise under less-than-ideal circumstances, and I look forward to talking about advocacy month in my next report.

Federal Policy Committee Meeting (Nov. 6)

I attended a meeting of CASA's Federal Policy Committee as vice chair, which ran smoothly and mostly consisted of all its members presenting their policy work (my area of focus was the exemption of parental and spousal income from the Canada Student Loans income assessment).

Provincial Advocacy

CAUS Policy Committee Meetings (Oct. 16)

I had two meetings on October 16 with individual members of the CAUS policy committee (which I chair) in order to get everybody in the committee up to speed on our workplan. I hope to have all the members' policies in the final review stage by the end of the month.

Ongoing Small Council Meetings (every Thursday)

I have continued attending meetings in my capacity as a CAUS representative with the Alberta Students' Executive Council (ASEC) and the Alberta Graduate Provincial

Advocacy Council (ab-GPAC), which have evolved into a very promising forum for cooperation between our three provincial student advocacy organizations. Our focus has been the ongoing Alberta 2030: Skills for Jobs postsecondary review and its implications for students in Alberta.

Municipal Advocacy

Overarching UPass Contract Negotiations (Oct. 20)

The UPass negotiating team met with ETS to discuss some of the final details of our agreement-in-principle, which will be coming to Students' Council for approval as soon as it is completed. I can't wait to share all the details of what we have won on behalf of students, so keep your eyes peeled for either our December or January SC meeting!

ESA Meeting (Oct. 23)

The Edmonton Student Alliance met to discuss a number of issues, including the thenupcoming city councillor forum, the ESA's strategic plan, and its priorities document. We also had a very productive brainstorming session regarding how to raise the ESA's profile in municipal affairs, and how to circumvent the problem of not having a permanent staff due to an absence of membership fees.

UPass Negotiating Team Meeting (Oct. 27 + Nov. 4)

The UPass negotiating team (consisting of SAMU, NAITSA, SANQC, UASU, and UAGSA) met twice to discuss elements of the agreement-in-principle which required clarification. As soon as these details are no longer confidential, brace yourselves!

ESA City Councillor Forum (Oct. 29)

The Edmonton Student Alliance had a very successful city councillor forum on October 29, which saw participation by four Edmonton city councillors and a number of student representatives from Edmonton. The conversation was pleasantly collaborative and productive, and covered topics ranging from changes in the law governing municipal elections to the long-term role of the ESA in shaping municipal strategies and policies.

University Relations

Tuition and Mandatory Non-Instructional Fees Discussions and Prep. Meetings (Oct. 16, Oct. 22, Oct. 27, Oct. 30, Nov. 3, Nov. 5)

I joined the rest of SAMU's Executive Committee for several preparatory meetings and discussions with members of MacEwan's administration regarding tuition and mandatory non-instructional fees.

Monthly meeting with VP University Relations Myrna Khan (Oct. 27)

I met with Myrna Khan to discuss a number of issues, including the relevant-at-the-time AUPE strike and ongoing labour union action, cooperation on the issue of SmartFare (which will be introduced when the UPass contract returns), and the ongoing Alberta 2030 postsecondary review.



Leadership and Review Committee Meeting (Oct. 30)

I chaired the final meeting of this iteration of the Leadership and Review Committee at the end of last month! I would like to take this opportunity to sincerely thank Councillors Hale Johnston and Ahsan Hassan, as well as our student-at-large Dylan Termeer, for all their fantastic work on LRC. Their insight and creativity made the committee a pleasure to chair, and I'm proud of how our (mostly) revamped SC evaluation form turned out, as well as the many other initiatives that will be carried on by the next Councillors and students who sit on the committee.

Students' Council Training (Oct. 30 + 31)

Need I say more? I joined the rest of Students' Council and a few prospective Councillors (who have now been formally appointed, congratulations!) for our SC training days, which went off quite successfully, in my humble opinion.

Mid-Year Executive Committee Retreat (Nov. 9 – 12)

Last week I joined my fellow EC (except for our VP Operations and Finance, who joined us digitally) on a mid-year retreat to Banff! Before you start picturing luxurious spa days and skiing trips, we spent 80% of our time in a conference room having wonderfully productive conversations about big picture topics like revenue diversification, the SAMU building, and governance structures. That might sound sarcastic, but I did genuinely enjoy it, and I am very proud of the work that we were able to do in such admittedly beautiful scenery.

Closing Remarks

It's official, November has been the busiest month of my whole term so far! My sincere apologies for how late this report is, but I swear it isn't the product of laziness. Hello councilors, I hope that you are all staying safe and healthy!

Projects & Initiatives:

Committees:

I have had no Bylaw and Policy Committee, Procedure Sub-Committee, Health and Dental Sub-Committee or Budget and Finance Committee meetings in these last couple of weeks as other items have taken precedent and also due to testing positive for Covid-19.

Other Business:

Covid-19 impact on the SAMU building and operations:

First Floor Quiet Study Space - The quiet study space beside the elevator on the first floor will be closed temporarily in an effort to control issues where students are spending extended periods of time in close proximity without masks. Our staff has witnessed numerous instances of students not wearing masks in that space, and given the close proximity of the room, and the difficulty in monitoring this space, we have decided that it is prudent to close the space temporarily. We will monitor progress with Covid-19 rates, and further regulations and messages from AHS and MacEwan to consider when we will determine it is appropriate to reopen this space to students. We have lots of space still in the building, but this area we have had the most trouble with compliance and for everyone's safety the senior leadership team feels that a temporary closure is best at this time.

Due to Covid-19, our tenants will not be restarting their build outs and it has been postponed until the Fall 2021 term until further notice. Covid-19 is the only factor for this business decision. Our tenants have done minor mechanical work to their units but the majority of the work is on hold. When the majority of students are back on Campus we will have our tenants open then. Trying to open would be one way ticket to bankruptcy and we couldn't force them to open.

Even with all of the Covid-19 costs, we are still well within our operating budget.

Graham is wrapping up their last test that they are have to do in accordance to the building requirements. The building passed the water barrier testing but didn't pass the smoke testing so they had to do more work to the pedway to correct this. This test should be done with in the next couple of weeks. Then the deficiency work should all be done and only warranty work will be left.

IMPORTANT: Our Gallivan representative is working remotely now and won't be back until the winter term. They will be here for the start of the Winter term until the Opt-out date then they will return to working remotely again. This is both due to Covid-19 and for her own safety, but also

due to the lack of traffic after the drop-deadline. She will still be available by email or phone for any questions

Tuition and MNIF consultation with MacEwan

Your executive team and I were fortunate enough to be able to attend and consult with MacEwan on the 2021/2022 tuition and mandatory non-instructional fees(MNIF) planning. Due to the confidentiality of the nature of this information, we cannot discuss what has been brought up, but if you have any opinions or suggestions, you can bring that forward to your EC team. The Board of Governors will review the information and the recommendations from MacEwan and we should have an outcome in the next month or so.

Director of Finance

I would like to wish Joanne our director of finance a healthy and safe maternity leave and I would like to welcome her temporary replacement, Justin. Justin has covered Joanne's last maternity leave and we are fortunate to have him back again. I am confident in Justin's understanding of the work at SAMU and I look forward to working with him.

EC Retreat

Your EC team had a great retreat and it was very beneficial to have. Unfortunately, due to Covid-19, I was unable to attend physically, but I was able to attend virtually. Even with the complications of technology, we were still able to do some teambuilding and come up with great ideas that I am excited to bring to life.

Virtual Open house

Unfortunately, we did not get a big turnout for Sean's and I's session, but I think it went really well and was informative. I do not know how the other sessions went. I am following up with Marketing and Communications.

SAMU Staff social 'committee'

Our Halloween social 'events' have gone well. We had a little contest for the staff to submit their favorite Halloween movie, we also had little goody bags for all the ghosts and ghouls at SAMU. We are planning our 4 weeks of Christmas/Holidays and I am thoroughly excited for our events and the launch of the new SAMU intranet.

U-pass

If you have not already read your VPE's last report, he had mentioned that there will be no U-pass for the winter term. We will be using the Force Majeure clause in the U-pass agreement. For more information, please ask your VPE. I just wanted to say that I have officially submitted that to MacEwan and it should be removed from the student fees. If for any reason it has not been removed from your account, please let me know and I will get that fixed.

Monthly connection meeting with Rick Ellis, AVP Finance and CFO at MacEwan Unfortunately, a lot that was discussed was confidential in nature as it related to the planning of the tuition and fees of future years. What I can disclose is that I am working with Rick on our service level agreement between MacEwan and SAMU which also determines our payment

Update from MacEwan:

Airmark operates Tim Horton's and Starbucks, but MacEwan does get a commission. They did the analysis and it costs them too much to prep and open for the amount of students on campus. It is like the Summertime volume.

Revenue is down in residence, parking, roundhouse, social innovation, etc.

Residency: Due to Covid-19, they are not allowing roommates, so individuals get their living area all to themselves. Unfortunately, to try and recover costs, they have had to remove the long-term stay discount rate from my understanding. There is still a designated floor for international students. All social and study lounges are closed. Please contact residency for more information.

MacEwan is over budget on the Covid-19 costs. It is believed that due to these extra costs, MacEwan will have no surplus this year.

Marketing:

I am working with our marketing team on a 'how-to' Health and dental video for the winter term and getting ready for other initiatives like town hall and Campaigning 101 for EC elections.

Dedicated Advocacy

Tuition and Mandatory Non-Instructional Fees (MNIFs) Meetings

Over the course of the reporting period, myself and the other members of EC attended several meetings about tuition and mandatory non-instructional fees with MacEwan's central administration. These meetings were productive overall, and I'm grateful to see that MacEwan is increasingly involving students in the decision-making process. From a student life perspective, this has been a difficult year for a host of reasons; and while fee increases of any kind are not ideal, centering student consultation is a good first step in ensuring that the student experience at MacEwan is maintained and improved in spite of the challenges.

AVP Students Consultation and Town Hall

Myself and the other EC members attended a consultation and a town hall focused on issues that should be prioritized in seeking a new AVP Students. I got to provide some meaningful feedback in these sessions, and I'm looking forward to seeing how everyone's suggestions are incorporated.

SVPEC - OSVPER Governance Structure Review Subcommittee

I attended one meeting of this subcommittee over the reporting period. Discussion was focused mainly on methods of sexual violence prevention and education program governance from across the country. I'm very excited to continue my work with this group, as I feel it is extremely relevant to some of my more internal work and to the challenges that students and administrators will be facing in the years to come.

SVPEC - Restorative Justice Subcommittee

I'm very excited about the direction that this committee's work is taking so far! I lead a discussion in our most recent meeting on an article about the pitfalls of a criminality approach to responding to sexual violence on post-secondary campuses. It was great to hear the perspectives of committee members on how this applies at MacEwan. I'm looking forward to getting more familiar with the literature on restorative justice for sexual violence so that I can continue to advocate for these options on campus.

Commitment to Sustainability

Appointment Advisory Committee (AAC)

The Appointment Advisory Committee has been busy conducting interviews over the last couple of weeks in preparation for the special meeting of Students' Council. I'd like to extend my thanks to all of those who applied to fill the vacancies!



Students' Council Training

I attended the Students' Council training on Halloween weekend (Halloweekend, if you will) along with all the other Students' Council members and those who applied for appointment. I think it went very well despite being virtual, and it was great to see folks engaging with the material.

SAMU Intranet Implementation

I was asked to be part of the SAMU Intranet implementation committee and have attended one meeting. The organization-wide introduction to the program is happening soon - I can't wait to see what folks think of it! I think it will do a lot for our internal communication, especially with so many folks working remotely right now.

Student Refugee Program

With the winter semester fast approaching, our SRP Committee has been been busily preparing for the arrival of the sponsored student. While no dates have yet been confirmed, we are hoping that all will go forward as planned for their arrival.

Connect to Students

Fall Webinars and Related Meetings

I participated in MacEwan's online Open House event on November 7th. Despite some tech difficulties and low turnout, I had fun helping other EC members provide some insight for a high school student considering attending MacEwan.

Enhance the Student Experience

Pride Planning

Sexual Violence Awareness Week Debrief

Chief Returning Officer Report to Students' Council

2020 SAMU Students' Council Election October 13-15, 2020

Introduction

The Fall 2020 Students' Council elections for the Students' Association of MacEwan University (SAMU) was one that had its own set successes and challenges, with one of the largest challenges being on how to conduct this SAMU election cycle during a worldwide pandemic. Planning ahead was crucial to conducting a successful election and the Chief Returning Officer's Office is grateful to the continual communication, collaboration, and preparedness of the SAMU Governance Office, as led by Mr. Alan Honey. Without that support we would not have been able to conduct and complete this important virtual process.

The 2020 Students' Council election took place over three days, October 13-15, 2020. The election was free of major controversy and saw four (4) Councillor positions filled out of a possible fourteen (14). Over almost two weeks of campaigning, five (5) candidates vied for positions on the Council, resulting in 875 members out of 15,378 edible voters casting ballots – a 5.69% turnout.

A Facebook AMA (ask me anything) was hosted by SAMU for all candidates to participate on October 6, 2020. Two virtual Candidates Forums were held by SAMU election officials over the course of the election, on October 7th and 8th, 2020.

On October 20, 2020, with no election appeals filed, the results below became official and are now considered final:

Election During a Pandemic

Before the 2020 Students' Council election commenced, the SAMU Governance Office was planning on how to run this election virtually due to the closing down of public spaces because of the spread of COVID-19 in March 2020. In collaboration with the CRO, the Governance Office and SAMU elected officials updated the *Procedure – Elections* to add the ability for the executive committee to declare an 'Extraordinary Event' via motion in situations where normal or regular physical access to the MacEwan

University campus is limited. This declaration would allow the CRO, limited to only one election cycle, to approve alterations to the hard copy submission requirements for campaign expenses and nominations. This new 'Extraordinary Event' mechanism was utilized for the 2020 Students' Council election and was of great assistance in ensuring the election could continue with no delay and little electoral structural change.

Voter Turnout

Turnout for this election cycle was a historic low for SAMU. At 5.69% turnout, this past election had a couple factors at play that likely contributed to this result. Moving to an almost completely online format for campaigning, with minimal physical campaign sign and poster presence on campus, was likely one of those factors.

Candidates are usually the best promoters of an election, being closest on the ground with students/voters and providing valuable election-related information when asked. This was hampered with a limited candidate pool (five candidates for fourteen positions) and a global pandemic limiting candidates' ability to speak to students face-to-face as is usually common.

It is recommended that increasing interest in running for Students Council needs to be made a high priority for SAMU for future election cycles. Without a large pool of candidates, it is harder for awareness of the election to permeate the MacEwan Campus at large and thus impacts voter turnout. It is also recommended that if a prolonged pandemic continues to impact election turnout that SAMU look to develop an virtual elections engagement strategy to implement in 2021 that takes into consideration a set of new participation incentives (ex. draws for prizes for voting participation), awareness through online local influencers (ex. paid sponsorship of election awareness social media posts from MacEwan and/or Edmonton's local influencer community), and any other online engagement practices deemed viable.

Online Election Analytics

- Average watch time was 0:36

- 428 total minutes viewed at time of data collection
- 239 people watched for 10 seconds or more
- Average watch time was 0:19 seconds

SAMU Elections Webpage:

- Since Sept. 9, there were 401 page views (182 of those were unique individuals)
- Average time on the site was 0:59 seconds
- Since Oct. 5 there were 27 page views (10 of those were unique)

Instagram:

- SAMU stories gained a high of 577 views for the candidate profile slides, with a low of 245.
- Completion rates (people actually watching the stories all the way through) was also quite high. No data provided on this at this time.

CRO Decisions and Interpretations

There were a couple instances during the course of the election that significant CRO decisions had to be made in order to ensure a smooth, controlled process. Important decisions and interpretations are summarized here:

Confirmation of Candidates

On September 29, 2020 two potential candidates were informed they were not eligible to stand in the 2020 Students' Council Election due to failing to meet criteria set in SAMU Bylaws. The potential candidates were given the opportunity to seek corrective actions and to provide any evidence of error on the part of MacEwan University or SAMU in order to become an approved candidate. No new information that would have validated their candidacy was received by the CRO or DRO (Deputy Returning Officer) before campaigning started on October 5, 2020.

I wish to thank DRO Alan Honey, Karen Schermerhorn, Connor Corsaro, Dave Kimmel, the MacEwan University IT staff, and all SAMU staff who helped put on this election during these strange new times – your efforts were tremendous! Many thanks and I hold you all up for your important role in this process.

Bylaws and Policy Committee

Mandate

1 Bylaws and Policy Committee ensures the relevance and consistency of SAMU Bylaws and Policy.

Roles of Committee

- **2** Bylaws and Policy Committee ensures the proper and timely review of SAMU Bylaws and Policy.
 - 2.1 Bylaws and Policy Committee utilizes the policy review regulations set in Policies
- **3** Bylaws and Policy Committee may create or recommend amendments to a particular bylaw or policy.
- **4** Bylaws and Policy Committee ensures the alignment of Policy with the SAMU Bylaws, Vision, and Mission.
- **5** Bylaws and Policy Committee consults with SAMU staff in the course of its deliberations where the creation and revision of policies affects department operations.

Composition

- **6** The voting members of Bylaws and Policy Committee are one Executive and three Councilors.
- **7** The resource officials of Bylaws and Policy Committee are the Governance Advisor and the Chair of Students' Council.
 - **7.1** Any member of Students' Council is entitled to attend a committee meeting in a non-voting capacity.

- 8 Meetings of Bylaws and Policy Committee are held at least twice per term.
- **9** The Committee Chair may call additional committee meetings as required.



Audit Committee

Mandate

1 Audit Committee assists Students' Council in fulfilling its financial oversight responsibilities.

Roles of Committee

- 2 Audit Committee monitors, evaluates, advises, and makes recommendations on:
 - **2.1** matters affecting external, internal, or special audits;
 - 2.2 policies and practices related to internal controls; and
 - **2.3** compliance with legal, statutory, and regulatory requirements.

Authority

3 Audit Committee is granted unrestricted access to SAMU information relating to its mandate or to the roles of the committee.

Composition

- **4** The voting members of Audit Committee are three Councilors and two students-at-large.
 - **4.1** If voting positions of the Audit Committee cannot be populated by Councillors, students-at-large will fill the remaining positions.
 - **4.2** Preference will be given to students-at-large with financial experience.
- **5** The resource officials of Audit Committee are a public member with professional accounting experience and a full-time staff member of the Finance Department.
- **6** No SAMU official with signing authority may serve on Audit Committee.
- **7** Any Councillor is entitled to attend a committee meeting in a non-voting capacity.

- **8** Audit Committee selects a Chair from among the Councillors on the committee.
- **9** Regular quarterly meetings of Audit Committee are held once per fiscal quarter, on dates determined at the first meeting following the initial appointment of Councillors to committees.
 - **9.1** Voting members who fail to attend a regular quarterly meeting are automatically removed from the committee.



- **10** The Committee Chair may call additional meetings as required.
- **11** SAMU's auditors may advise and present to Audit Committee when required and as part of the audit process.

Standing Orders

- 12 Audit Committee reviews Executive spending and work, vacation, and sick hours quarterly.
- **13** Audit Committee reviews budget variances quarterly.
- 14 Audit Committee reviews out-of-budget and exceptional authorizations or expenses.
- 15 Audit Committee reviews compliance with recommendations made by SAMU's auditors.
- **16** Audit Committee reviews the performance of the auditors and may, at its discretion, recommend to Students' Council a change in auditors.
- **17** Audit committee may add to its work plan any item of concern relating to its mandate or roles which has been brought to its attention by committee members, Councillors, Executives, SAMU staff, SAMU members, or SAMU's auditors.
 - **17.1** The identity of any individual who brings a concern before Audit Committee is kept confidential and is not disclosed during Audit Committee investigations, in minutes or in reports.



Budget and Finance Committee

Mandate

1 Budget and Finance Committee oversees the construction of the SAMU budget, assesses and reviews SAMU fees, and reviews SAMU financial statements.

Roles of Committee

- **2** Budget and Finance Committee compiles, creates, and submits the annual SAMU operating budget to Students' Council for approval.
- **3** Budget and Finance Committee monitors and recommends adjustments to the SAMU Membership Fee.
- 4 Budget and Finance Committee monitors the financial well-being of SAMU.
- 5 Budget and Finance Committee provides recommendations regarding new or current SAMU fees.
- **6** Budget and Finance Committee monitors SAMU's investment accounts.

Composition

- **7** The voting members of Budget and Finance Committee are the President, the Vice President Operations and Finance, the Vice President Student Life, two Councillors, and two students-at-large.
 - **7.1** Preference will be given to students-at-large with financial experience.
- **8** The resource officials of Budget and Finance Committee are the General Manager and a full-time staff member of the Finance department.
 - **8.1** Any member of Students' Council is entitled to attend a committee meeting in a non-voting capacity.

- **9** The Vice President Operations and Finance serves as Chair of Budget and Finance Committee.
- **10** Meetings of Budget and Finance Committee are held at least quarterly.
- **11** The Committee Chair may call additional meetings as required.



Governance Remuneration Advisory Committee

Mandate

1 Governance Remuneration Advisory Committee annually reviews the remuneration and compensation provided to Councillors, Executives, and other committee members performing governance roles at SAMU.

Roles of Committee

- **2** Governance Remuneration Advisory Committee provides recommendations to Students' Council on remuneration and compensation adjustments of Councillors, Executives, and committee members.
- **3** Governance Remuneration Advisory Committee seeks relevant internal and external data related to remuneration and compensation, including:
 - **3.1** the current and future financial capacity of SAMU to support new levels of remuneration;
 - **3.2** remuneration and compensation offered at other comparable Alberta-based students' associations/unions;
 - 3.3 the effectiveness of the current level of remuneration in securing representatives; and
 - 3.4 the fairness of remuneration based on factors such as workload, time commitment, etc.
- **4** Governance Remuneration Advisory Committee reviews Executive wages as per *Remuneration of Elected Representatives*.

Composition

- **5** The voting members of Governance Remuneration Advisory Committee are one Executive, one Councillor, two student-at-large members, and one public member.
- **6** The resource official of Governance Remuneration Advisory Committee is a full-time staff member of the Finance department.

- 7 Meetings of Governance Remuneration Advisory Committee are held at least once per year.
- **8** The Committee Chair may call additional meetings as required.



Leadership and Review Committee

Mandate

1 Leadership and Review Committee is a semi-judicial body which advises and reviews Students' Council, and strives to maximize student engagement.

Roles of Committee

- 2 Leadership and Review Committee reviews the performance of the Chair of Students' Council.
- **3** Leadership and Review Committee reviews Students' Council's decisions in relation to their adherence to SAMU Bylaws and Policies.
 - **3.1** Leadership and Review Committee may call a re-vote on a decision where it deems the decision was a violation of Bylaws or Policies.
 - **3.2** Members of Students' Council may request a review of a decision in relation to its adherence to Bylaws and Policies.
 - **3.2.1** Requests must be made in writing to the Chair of Leadership and Review Committee within 10 days of the disputed decision.
 - **3.2.2** Leadership and Review Committee will have 30 days to respond in writing to Students' Council with its decision.
- **4** Leadership and Review Committee creates opportunities for members of Students' Council to develop leadership skills by:
- **4.1** researching and implementing applicable professional development opportunities for members of council; and
 - **4.2** developing team building opportunities for Students' Council.
- **5** Leadership and Review Committee develops a plan for Student Council to engage with SAMU members.
- **6** Leadership and Review Committee reports on the effectiveness and progress of Students' Council.

Composition

- **7** The voting members of Leadership and Review Committee are one Executive, two Councillors, and two students-at-large.
- 8 The resource official of Students' Council Review Committee is the Governance Advisor.
 - **8.1** Any member of Students' Council is entitled to attend a committee meeting in a non-voting capacity.



Committee Operations

Meetings of Leadership and Review Committee are held at least twice per quarter.

The Committee Chair may call additional meetings as required.



Appointment Advisory Committee

Mandate

1 The responsibility of the Appointment Advisory Committee is to interview and vet candidates for appointments made by Students' Council, and to vet and recommend student-at-large candidates for appointments by Executive Committee.

Roles of Committee

- **2** The committee reviews all applications for appointments made by Students' Council and Executive Committee, and ensures candidates considered for appointment meet the criteria for positions laid out in SAMU's bylaws and policies.
- **3** The committee develops additional criteria for appointed positions consistent with SAMU's bylaws and policies.
- 4 The committee interviews all appropriate candidates for positions appointed by Students' Council.
- **5** The committee provides candidates with further information regarding the position upon request.
- **6** The committee provides written recommendations on all vacancies.
- **7** The committee communicates to all candidates regarding the outcome of Students' Council appointments.
- **8** The committee works to create relationships with MacEwan faculty and the University community to fill student-at-large vacancies.

Composition

9 Voting members of the committee are one Executive, one Councillor, and the Governance Advisor.

- **10** The committee deliberations and recommendations are confidential.
- **11** Meetings of Appointment Advisory Committee are held at the call of the committee chair.

Health and Dental Sub-committee

Mandate

1 Health and Dental Sub-committee monitors and evaluates the Health and Dental Program administered by SAMU, provides a forum for Health and Dental contract renewals, and advises Executive Committee regarding decisions related to the Health and Dental Program.

Roles of Committee

- **2** Health and Dental Sub-committee reviews the Health and Dental program and its financial matters, including the cost of the program and fees charged to students.
- **3** Health and Dental Sub-committee oversees the "Request For Proposal" process for a new Health and Dental broker or provider.
- **4** Health and Dental Sub-committee reviews the contract and facilitates the negotiation process with the current Health and Dental broker and provider.
- **5** Health and Dental Sub-committee monitors, evaluates, and makes recommendations to Executive Committee on policies and strategic matters related to the management of the Health and Dental program.

Composition

- **6** The voting members of Health and Dental Sub-committee are two Executives, one Councillor, and two students-at-large currently enrolled in the SAMU Health and Dental Plan.
- **7** The resource officials of Health and Dental Sub-committee are the General Manager, and one full-time staff member of the finance department.
 - **7.1** Any Executive is entitled to attend a committee meeting in a non-voting capacity.

- 8 Meetings of Health and Dental Sub-committee are held at least once every three months
- **9** The Committee Chair may call additional meetings as required.

Awards Sub-committee

Mandate

1 Awards Sub-committee selects recipients for SAMU awards and honours and recommends the processes for creating and granting awards and honours.

Roles of Committee

- 2 Awards Sub-committee reviews all nomination applications for SAMU awards and honours.
- 3 Awards Sub-committee ensures each SAMU award has a Terms of Reference (TOR).
- **4** Awards Sub-committee recommends alteration to the *Award*s procedure to Executive Committee for approval.
- **5** Awards Sub-committee selects recipients of SAMU awards and honours based on criteria located in the TOR for each award.
- **6** Awards Sub-committee ensures that the selection process for award recipients is fair, unbiased, and transparent.
- 7 Awards Sub-committee recommends types of awards to be established or terminated at SAMU.
- 8 Awards Sub-committee submits reports to Executive Committee in January and April.

Composition

- **9** The voting members of Awards Sub-committee are one Executive, two Councillors, one student-at-large, and three full-time staff members.
 - 9.1 No more than one SAMU Director may serve on Awards Sub-Committee at a time.

- **10** Meetings of Awards Sub-committee are held at the call of the committee chair.
- 11 Awards Sub-committee deliberations and minutes are confidential.
