CH Okay, it's six o'clock. We'll call the meeting to order. If you're not speaking, I'll just ask you to please mute your microphone. And if you haven't already done so, please change your title, or your name to your title. So, we'll start with item number one, Treaty 6 Land Recognition.

We would like to acknowledge that this meeting of the Students' Association of MacEwan University is taking place on the traditional territories of the people of the Treaty 6 region in central Alberta. The Students' Association of MacEwan University is situated in the centre of what we call the city of Edmonton, which is called Amiskwaciy Waskahikan or Beaver Hill House in Nehiyawewin (Cree). This is the traditional home of the Nehiyaw and Michif, and meeting place for many Indigenous peoples including the Nakawe, Siksika, Nakota Sioux and other nations.

I just wanted to let everyone know that there is an opportunity for involvement by our Councillors or students at large if they are interested in taking part in a student focus group on online learning technology. But I thought I would just reiterate it here, because it was something that we've discussed a lot in Leadership and Review Committee, that on Friday January 29th, from 2pm to 3pm, Budget and Finance Committee is having a budgeting training session. So, the goal of that is to give everyone a bit more information around reading budgets, the budgeting process in advance of our annual budget being brought forward.

I just thought that I would really reiterate and strongly encourage, especially EC, but the rest of SC very much as well, to just participate in that, raise the level of financial literacy on Council. I think that would be a really positive opportunity.

And then I also wanted to add one more thing, which is something else that was discussed in our Leadership and Review Committee meeting today. This is just, I guess, a public service announcement, in-camera items or in-camera discussions should not be brought up in the Students' Council meeting evaluation forms that we fill out at the end of meetings, because we have students at large who sit on that Committee and review the evaluation forms with us. So, please do not refer to in-camera items or in-camera discussions directly in your meeting evaluation form.

If you have anything that you'd like to address about those items, I would ask that you include someone who was part of the in-camera discussion or just go directly to a member of Executive Committee, or Alan or someone like that.

And then just generally, I would like to reiterate that everyone on Council has a responsibility to respect confidentiality, respect in-camera discussions, and to not voice the content of those discussions outside. I know that there's a tricky grey area that we're currently dealing with, which is, if, for example, you're reiterating a private opinion that you



may hold, that you expressed in the context of an in-camera discussion, can you share that opinion outside, if you feel comfortable sharing your own information? It's a grey area right now. I would urge you to avoid it wherever possible, and to just be very sensitive about that.

If you speaking your opinion gives away the content of the discussion or alludes to what others' opinions were, I would highly suggest that we don't do that, just because it can compromise the functioning of Council. - EX Thank you, Chair. Here, let me just make sure that I have the motion in front of me. Basically, this is the culmination...

- EX Apologies. I was doing the introduction. I move to approve the 2021 U-Pass referendum question to be included in the March 2021 elections.
- CH Thank you, Vice President. And the second? Vice President Operations and Finance. It has been moved and seconded to approve the 2021 U-Pass referendum question to be included in the March 2021 elections. Vice President External, I'll give you the floor to introduce or to speak first about the motion.
- EX Thank you, Chair. I jumped the gun on that one a bit. But yes, so this is the culmination of our whole U-Pass negotiations that have been going on. So, if you have all gotten the chance to, and hopefully have, read this motion before the meeting, in the question, it basically details all of the updates that are being made to the U-Pass agreement.



So, one of the big things that I'll just highlight from the question. For example, we were able to get the same price for students for every year of the agreement, which I think is a pretty exceptional win. So, this is the question that we would be running alongside our EC elections, where students would vote whether or not they want to approve the deal that we have now negotiated.

If they do, then whenever the force majeure stops being in place, the agreement would come into play. Not all of the nitty gritty of the agreement has been worked out, but for a referendum question, we only need the agreement in principle, which agrees on all of the big changes. The rest is just going to be the legal language.

So, I'm happy to answer anyone's questions about this or give any more detail. But I think that the referendum question is quite thorough in covering all of the big points. Thank you, Chair.

CH Thank you, Vice President. So just so Council is aware, we are talking about the question to be included in the March 2021 election, not necessarily the deal. So, we'll just make sure that your questions or comments are germane and speak to whether or not you're in support of or in opposition to the motion. So, is there any other debate? If there is any other debate, I'd ask that you please type debate into the chat.

- OF Thank you, Chair. I move to approve the MyLegalPlan referendum question to be included in the March 2021 elections.
- CH Thank you, and a second? Councillor Tran, thank you. It has been moved and seconded to approve the MyLegalPlan referendum question to be included in the March 2021 elections. Vice President Operations and Finance, would you like to speak to the item? I think you're on mute.
- OF Thank you. So basically, the MyLegalPlan would be an additional benefit coverage that covers these legal supports for students. Students can opt out of this coverage. So, it is not 100% mandatory. It would be about \$21.41 per year. So, per 12 months. I got news today that they are reviewing the price and they're hoping to be able to reduce that price. But the maximum that students would be charged would be \$21.41.

I do hope that you were all able to read the documents and the info sheet. It does cover a lot, including \$1500 a year in legal expense, as well as we do have contact or a network of 3,000 lawyers that are all five years or more of experience. I do also have a couple of reps from Gallivan on the call here. So, if you have any questions, feel free to ask them, and we can answer any questions you have. So, thank you.

- CH Thank you, Vice President. Is there any additional debate? If there is, please type debate into the chat. Councillor Yanish.
- YA Thank you Chair. I would just like to speak in favor of this. I think it is, considering the price and considering you can get, if I read the document correctly, up to nine hours of legal counsel for roughly \$20, as someone who's been in a position who would have benefited greatly from having some very small legal counsel, I guess, using the same word. I think it's a great idea. And I see no reason to not support it. I love it.
- CH Thank you, Councillor. Other debate? President.
- PR Thank you, Chair. I guess I'll just echo the same thing as Councillor Yanish, and say that I do think it's probably a pretty good idea. Some of the Student Associations offer something similar. It would have an opt-out built in. And as you mentioned about U-Pass, same kind of deal here that you'd have to a referendum, so the students ultimately decide at the final juncture. But I think it could be a good way to mitigate potential risk and legal costs for students. It's probably a good plan, but if there's any curiosity or questions or confusion or anything, I'd highly encourage people to ask questions or keep contributing to this discussion.

CH Okay, so for those of you who are not familiar, I'll describe the process here. So, we have one vacancy on the Audit Committee, and we require nominees. And so, soon here, I will open the floor to nominations. If you have a nomination, you can either nominate one of your colleagues on Council or yourself. And you just type in nomination in the chat, I will recognize you in the order in which you've populated the chat. And then you can nominate one of your colleagues, at which point I will ask that colleague if they accept the nomination or not, or you can nominate yourself in which I will assume that you're going to accept the nomination.

> And so, once we go through the process of nominations, we will have 30 seconds for each of the nominees to relay to all of Council why they feel as though they should be the successful candidate for the Committee position. And so, we will run through the speeches in the order in which individuals were nominated. And once all of the speeches have concluded, we will move to an online ballot where all of you will be able to select who you wish to be appointed to the Committee. Whoever receives the largest number of votes will then be appointed to the Committee through this motion. So, is that not clear to anyone?

Are we able to nominate that Councillor for one of the Committees or both, I guess, Committee appointments that are coming up?

- CH Sure. It's probably a good refresher for us all anyway. So, Vice President Operations and Finance, would you like to give us a two-minute description of the Audit Committee?

OF Yes, thank you, Chair. So basically, what the Audit Committee does is that they monitor, evaluate, advise and make recommendations on matters affecting external, internal or special audits involving policies, practices related to internal controls, as well as compliance with legal statutory and regulatory requirements. So, the things that they will review are the Executive Committee's spending, their work, their vacation, and the sick hours.

They also would review the budget and budget variances quarterly. And then out of budget expenses that were authorized. And the auditors as well... I can't talk sorry. The auditors document that they provide us as well. And they usually meet on a quarterly basis. So, it's not that much of a high meeting committee, but it plays a crucial role in SAMU's process.

OF Yes, thank you, Chair. So, this policy has been reviewed for a little while now, even before my term started. We were trying to identify how we can be more transparent to our students, and how we can show them our financials in a way that will not share it with the public as well. So, when asked at Council, it was recommended by the auditors not to publish a full annual budget on the website, just to keep us safe and because the general public is not entitled to this information. It's only for SAMU members.

And so, we decided that we will add a general summary of the budget, highlighting the main areas and the departments as well. And this does not stop any Councillor from asking a SAMU member to view the full budget. It just helps the students have more information. Thank you, Chair.

- CH Thank you. Okay, so I'll open the floor to debate now. If there's any debate, please type debate into the chat. President.
- PR Thank you, Chair. Just quickly, I think we collect a not insignificant amount of fees from our members, and anything we can do to show them how we spend that is good. I think it's great to have improved transparency in this way and back up the organization and what we're spending students' money on with some more reporting. So, I'm heavily in favor of this. I think it's a great idea.

Item eight, consultation 8.1. Graduated fee proposal consultation. President, do you want to introduce the consultation item?

PR Sure, yes. Thank you, Chair. I nearly forgot this was on here. The backgrounder basically gives you everything you need to understand this, but I can give the overview of maybe why we're bringing this. It's been brought up by our general manager. We're spit balling the idea. And in a really rough way, we've just started discussing it. And it's been briefly mentioned at Budget and Finance Committee. I think at this really super early stage, we have to see if Council is interested in this at all. Because let's say Budget and Finance Committee produces something, it'll eventually have to come to Council for final approval. So, we need to know whether it's worth pursuing at all, and whether there's an appetite for it at Council.

So, I guess some specific examples of why a graduated fee proposal might be a good idea is we have students who are studying online and maybe live in a completely different municipality or a different province. Maybe they would have a different fee per credit. Same thing with, and this is the big one that really got us thinking about it, is the Ponoka campus. There're 200 students at the Ponoka campus who are paying the same fee per credit as every other student, as the city center campus students. And that, to me, doesn't seem quite right, since they don't get the same access to our services.

So, the background has a lot more detailed information. And just to let you know, this is to let all of Council know this is the approval basically, the go ahead for BFC to look into it, turn it over, think about it, propose some things along with our finance department, and then bring it back to Council later. So, the heavy lifting will be done in that forum. So that's my introductory comments. Please remember, everyone gets to speak only once in the consultation. As for the Councillors, get all your comments in on the first time you speak.

- CH Thank you for that reminder, President. You stole the words right out of my mouth. If you'd like to make a comment, please type in comment in the chat. Councillor Abboud.
- AB Yes, thank you, Chair. So, my only concern with this, even as a consult, is the potential to open Pandora's box. The amount of student fees that we already have that are allocated, there are hundreds of questions every semester about opting out, why do we have them? What are they for? And I just think that by separating those fees in accordance with what those students are is literally opening Pandora's box.

For example, I live on a ten-minute walk to the university, but I still mandatorily pay for the U-pass. Everything is a debate when it comes to these fees. And I think that to leave them on an equilibrium is the best thing that we can do. I have a gym membership at Goodlife, but I still pay for the health and wellness at MacEwan. Just because I don't use it, it just goes with it. And I just think that there is there's so many shards of glass to try and have these tiers and these categories that were mentioned in the report. I just think that it's opening Pandora's box, and I don't think that that box should be opened. Thank you.



CH Thank you, Councillor. Councillor Yanish.

YA Thank you, Chair. More or less, I'd echo a very similar sentiment. I had in my notes here almost the exact same wording, that it's a slippery slope, etc. So, to add something different, I would just say that I'm not entirely opposed to the idea. Although as contradictory as it may sound, it better have very, I guess... This is something that I think is very hard to execute. If executed properly, if it's a very little cost to SAMU as a whole. If this would lower our budget by 2% and increase our optics significantly, then great. I'm skeptical as to our ability to do that.

I think, again, slippery slope, Pandora's box, etc., would allow for many students to feel like, well, I'm in a very similar situation, I live very close to the university. Ironically, I did not make best use of the things I'm paying for, but I don't know. For me, it's somewhat reminiscent of the equalization payment debate we might hear in terms of Canadian politics.

All I have to say in conjunction with that, it is certainly a lot easier, not splitting hairs as to who is paying what, because we all know students can come up with a good reason, as they should, as for why they shouldn't pay for certain things. But I don't think that's a good precedent to set.

So, in summary, if it's going to be done, I'm not opposed to Committee looking at this and doing more work on this. But I think the bar is incredibly high, and I'm not confident, even despite our best efforts, that we'd be able to achieve that. But that's all I have to say. Thank you.

- AC Thank you, Chair. I really appreciate the comments so far. I think that is the crux of the issue. So, I really appreciate it. I'm also interested in hearing what the other Councillors have to say. Although it's mentioned only one spot each, we would love to hear from as many as we can.

I think there is definitely value to looking at a potential graduated fee structure, because there is some very clear, I think, routes or there is that level when it comes to, for instance, students at the Ponoka campus and their access to our services. But I think that should be defined for very few other circumstances, if any. So, I'm happy with the conversation to move forward, but I think they have to be very specific, and very few.

But I think the other side of it is more so looking at how we can provide services to our other students and provide services in a way that is going to be more inclusive, whether students are online learners or in-person as the COVID situation has shown us some ways that we can do that. So, that's where I see it going. I'd be very interested for those specific cases or for specifically defined cases, so that we avoid a potential slippery slope. But I'm interested to hear what others are thinking as well. Thank you.



CH Thank you. Vice President Operations and Finance?

OF Thank you, Chair. As being one of the main point of contacts from students in regards to fees, I just wanted to mention a couple of things. So, I've heard quite a bit from either online students or Ponoka students this year, in regards that they don't think that it's fair to pay the whole fee because they don't have access to our service. Currently, with COVID-19, most of our services have gone online. And so, it is accessible to all students, including the ones that are elsewhere.

But I had a student contact me today from Kalona, who was telling me that she doesn't benefit from any of these services. And so, that is one thing to consider. I am neutral on this point personally, but it is something that we can definitely look into. And like the VP academic said, it would be very minimal and small little exceptions. Thank you.

- LL Hi, can you hear me?

- LL I would like to share my opinion in favor of this motion. I would like to point out that specific to the Ponoka campus, I don't think it's quite comparable to something like the U-pass because the Ponoka campus lacks access to the resource almost entirely, while with a Upass, you can still use it if you choose not to. So, I think there is a difference between not making use of a benefit vs lacking access almost completely. Thank you.

- WI As it's been spoken to by almost every other Councillor that's spoken, it is a very high bar that needs to be set on making these divisions. But I do think it is something that we could definitely look into and see what BFC can come up with, in a sense of making these divisions. Thank you, Chair.

- CH Thank you. Other comments? Last call for comments. President, I'll give you the floor to wrap it up at the end here.
- PR Thank you, Chair. I think this is good feedback, because I agree with a lot of what's been said. I think that it is potentially a slippery slope, as Councillor Abboud said at the beginning, and it is definitely very difficult to isolate what the categories are, as Councillor Yanish said, and a lot of other comments are similar to that. But we're opposed, or at least cautious about it. I think that might warrant sending it to BFC, just to see what they might come up with.

But just quickly, I just want to reiterate that it's just the membership fee. So, it's separate from the dedicated fee units like U-Pass or health and dental, and it's separate from any MacEwan fee, any of those other MacEwan mandatory non-instructional fees. It's just the membership fee. So, I think all the points still stand, but it's good to clarify that. But the



points still stand that as soon as you start chipping away and giving reasons to not pay it, it may be a slippery slope to bring on further reasons.

I just want to say quickly that the Kolona example, I haven't investigated that fully yet, but if they are paying membership fees, maybe that's a good example. If your postal code is in a different province, maybe that's one. And I think Ponoka for sure is one, because we can put a lot of things online, and I know somebody said that and I think I think it was VP Academic. And you're right, we can put a lot of things online, and they can be high quality. They can be great services. But we can't put the food bank online and we can't put Breakfast Club on. So, if we were to keep charging the same fee, we had to find a way to deliver that service at that campus.
