CHA Okay. We'll call the meeting to order.

Item 1. Treaty 6 Land Recognition. We would like to acknowledge that this meeting of the Students' Association of MacEwan University is taking place on the traditional territories of the people of the Treaty 6 region in central Alberta. The Students' Association of MacEwan University is situated in the centre of what we call the city of Edmonton, which is called Amiskwaciy Waskahikan or Beaver Hill House in Nehiyawewin (Cree). This is the traditional home of the Nehiyaw and Michif, and meeting place for many Indigenous peoples including the Nakawe, Siksika, Nakota Sioux and other nations.

5.2. Oral Questions. We'll open question period now. If you have a question, just please type in, question, in the chat. Councillor Williams?

- CWI So, this question is for the VPA, regarding the GFC meeting, where the Student Code of Conduct was approved and the rescission of the Student Rights and Responsibilities document. Do you know when the Student Code of Conduct is going to be put in place? Is there a timeline? Or a specific date for that to happen? Or anything else along those lines? Thank you, Chair.
- CHA Thank you, Councillor Williams. Vice President Academic?
- VPA Thank you, Chair. That's an excellent question. My understanding, and I might have to follow up with you as I just check back with how the motions were read. But I believe at that GFC meeting, since it has been approved at that level, now the Student Code of Conduct stands. And I guess, in effect, in the Rights and Responsibility document is officially rescinded, because it has already gone through the processes. And that was the last stamp of both of those approvals that was necessary.

I will just add that we did not... Just because we got a Student Code of Conduct and this is replacing the Student's Rights and Responsibilities document, that this does not remove any of our student's rights. It, instead, these rights are already in other policies. And now it's up to our SAMU.

We will be taking on a student, a Charter of Rights, so that we will be able to compile all the student's rights. So, they'll be in one place. But it's not taking any of them away. It's just taking away the duplication of them and then in a document that highlights that expectations that students are supposed to follow as a guideline. So, hopefully, that answers your question, Larissa. But I can definitely follow up with you, if there is any implementation dates that I am aware of. But it should be standing now.

- CHA Thank you, Vice President. Councillor Williams, anything further?
- CWI No, that was everything. Thank you, Chair.
- CHA Thank you. Councillor Semotiuk?
- CSE I also had a question for the VPA. On your report that you sent out to us, there was a thing that discussed about the Microsoft products with the Information Technology Management Committee. I was just curious if there is a plan, especially whatever the fall is going to look like for MacEwan, if we're ever going to get access to Microsoft's Teams, using our Student ID? Just curious.
- CHA Thank you, Councillor. Vice President Academic?
- VPA Yes. An excellent question and one that we actually had discussed at that ITM meeting.



My understanding, currently, is that technically with this offer that we have access to in the Microsoft package that students have access to, technically, Teams could be a part of it. But MacEwan has turned that off, I guess, for students. And we don't have access to it, while staff do. I don't think... That's currently under consideration, I believe. From my memory I'm unsure if it is something... It's basically under consideration whether they will look at that as an option for students.

So, if you have any feedback on what your preference is or if you do have a preference or an opinion on the use of potential Teams, please do send that to me. But, currently, I don't believe that is in the works. It's just, kind of, under consideration.

- CSE Sure, yes. I'll send you an e-mail. I just had some thoughts on it. Okay. Thank you.

And the other one was removing Spousal Contributions from your needs assessment with Canada Student Loans Program. So, I put them together into a single policy and revamped them with some new data and everything.

But, yes. Like I said, there's no snappy way of saying it. But essentially this just allows people to be assessed as individuals when they apply for federal student loans. Thank you, Chair.

If you read my report you would see it as an appendix in my report, the majority of the changes to the workload distribution can be done by Executive Committee [unclear] have already been done at last weeks Executive Committee meeting. Yes. So, it was exactly one week ago, I believe. Yes. That was on February 10th.

So, almost all of them have been done except for the ones the Council has to approve. The reason Council has to approve them is because they are explicit... Like, a Chair position in the Budget and Finance Committee that is explicitly listed as being for the VP operations. The only way that we can change that is through Council. And, yes. All the other context is there, I believe. The only one that's coming to mind at the moment... Sorry, I don't have the agenda right in front of me. The only one that's coming to mind at the moment is that Budget and Finance Committee Chair. So, yes. I'll leave it there and open the floor for discussion and the vote later.

The governance side seems very accepting of what the administrative side wants to do, budgetarily. So, my bet is we'll submit it on Friday and I'll be in place as Chair to do that.
