Dear Council,

Below is my report on my work as President between June 10th to July 14th.

Student Voice

CAUS Board Meetings (June 14th, June 28th, July 12th)

Much of the discussion surrounding the CAUS table has been regarding the membership fees for the organization for the 2021/22 fiscal year. There were a couple options presented but ultimately, it was decided that we would move forward with a CPI increase. SAMU supported an increase in accordance with CPI and looking at a substantial increase in fees after an organizational review has been completed. With consensus achieved surrounding the fees, the 2021/22 budget was passed. CAUS also approved four of our five advocacy priorities for the upcoming year, and they are as follows: healthy and safe campuses, student financial aid, expanding affordable child care, and access to broadband internet.

Meeting with Dr. Trimbee (June 16th)

I met with Dr. Trimbee in our regularly scheduled meeting. Topics of discussion at this meeting were EDI, Indigenization, and the structure of the SAMU/administration meetings. I voiced my support for MacEwan's EDI Plan, which focuses first on ascertaining EDI-related data in order to create targeted supports at a later time. On the topic of Indigenization, we discussed ways to Indigenize MacEwan and lead economic reconciliation. MacEwan often uses the term Indigenization rather than decolonization, acknowledging that universities are an inherently colonial institution and can never be separated from its roots. As well, Indigenous peoples are put at the forefront rather than colonization.

Meeting with Faculty Association Rep. (June 21st)

In my meeting with the Chair of the Faculty Association's Job Action Committee, she emphasized the importance of the student experience in any conversation surrounding job action. The FA is in the early stage of negotiations for their collective agreement with the university, and are planning for all possibilities.

CAUS Organizing and Public Engagement Committee Meeting (June 21st)
This committee met for the first time this year, and we elected our chair. Rowan Ley, current president of the University of Alberta Students' Union and former chair of CAUS, was elected and I'm excited to see how SAMU can contribute to the campaigns of CAUS!

CAUS Policy Committee Meeting (June 21st & July 5th)

At our first meeting, we elected Karen Fletcher, the Vice President External for the Athabasca University Students' Union, as chair of the policy committee. The subsequent meeting jumped into some important topics, such as developing a land acknowledgement unique for CAUS as well as establishing a three-year strategic plan.

Meeting with Manager of Student Life new AVP Students (June 22nd)

The Executive Committee got the opportunity to meet the new AVP Students, Tim Tang as well as have our reoccurring meeting regarding Student Life. Some of the priorities described by Tim in his role were to better support and identify risks to students with targeted supports, bolster student engagement, and take an interdisciplinary approach to his work. The Student Life team is hard at work on the First-Year Mentorship program, which will see approximately 40-50 students in their first year paired with a mentor who can help them as they engage with the university community.

Convocation Recording (June 23rd)

As the president of SAMU, I recited the student invocation. While this was recorded in June, it was shown at convocation on July 13th.

MacEwan United Way Committee Meeting (June 25th)

At the committee meeting, there were updates on the Rock the Block event planned for September as well as new projects such as a Financial Literacy Guide, Student Mental Health, and the Dare to Dream campaign. The Dare to Dream campaign builds on UW's campaign All In For Youth, which was created in response to one in five youth not graduating on time. With Dr. Trimbee, her and I will be visiting class rooms to give different perspectives to the university experience.

Meeting with AVP Alumni (June 25th)

The Alumni Development Office reached out to me to give my feedback on their upcoming modular fundraising campaign for the Centre of Sexual and Gender Capacity. One aspect of the fundraising is for scholarships and bursaries for LGBTQ+ students, as members of the community often graduate with higher levels of debt than the average student. They're looking to involve more young folks in their fundraising and I made some suggest

Edmonton Student Alliance Meeting (June 29th)

We held our first meeting with all of the members' new executives. As Sean held the chair of ESA this past year, I chaired the meeting. We elected a new chair and Christian Fotang, the VP External of the University of Alberta Students' Union, was successful in his bid. The position of vice chair was not filled, but we will elect one hopefully at a later date.

Meeting with Director of OHRDE (June 29th)

In my campaign platform, one of my goals was to work towards unconscious bias training for staff. The VPO, VPSL, and VPA have been collaborating with me on this initiative and this meeting was a step in fleshing out the project more. The VPSL and I

attended this meeting with Irfan with a couple goals in mind; does the OHRDE have the capacity to upscale its training to a broader audience, and what policy instrument could be utilized to implement the objective? I was eager to hear that the Office is developing more training for staff and faculty, such as an inclusive communications training. Ultimately, Irfan did not believe that the Office had capacity and moving forward, I will advocate for additional budgetary allocations towards the OHRDE and the greater EDI initiative at MacEwan.

SAMU/UCSU Meeting (July 8th)

Our General Manger, Advocacy Coordinator and myself initiated an introductory meeting with the University of Calgary Students' Union's (UCSU). We discussed some high level plans for the year ahead as well as how to approach the discussion of an operational review at CAUS in the year ahead.

Mary Burlie Day (July 13th)

This was the first event I had the opportunity to attend in-person in my role as President, and it couldn't have been for a greater cause. Mary Burlie Day came about from conversations between Boyle Street Community Services and MacEwan as we both plan our 50th anniversaries and it was discovered there is a MacEwan bursary in her name. Mary Burlie was a Black woman born in Arkansas under Jim Crow law, and later in life moved here to Edmonton. Drawing on her own experiences of oppression, racism and poverty, she was a champion for people experiencing homelessness in downtown Edmonton. She was one of Boyle Street's first volunteers and staff, and was known as the "Black Angel of Boyle Street" for her compassion. The VPO and I attended this event on the Allard Lawn and there were remarks from President Trimbee, the ED of Boyle Street, MP James Cumming, MLA David Shepherd, and Councillor Scott McKeen.

Strengthening SAMU Operations

Healthy Campus Alberta Wellness Summit (June 15th-17th)

The EC attended Health Campus Alberta's annual wellness summit. As a community of practice, HCA gathers members of the larger PSE community in order to share best practices and information on how to create safer, more inclusive campuses. The focus of this summit was story-telling and the power of sharing our narrative.

EC Teambuilding (June 22nd & 23rd)

Working in a virtual environment made teambuilding unique. In the office, teambuilding can be those casual interactions like hallway chats, working in one another's offices, and going to get coffee. Now, teambuilding must be intentional, so we've been setting aside a couple hours here and there to have a time for getting to know one another.

CASA Series (June 23rd & June 30th)

Our federal advocacy group has been running a series of events to build delegate and executive knowledge on topics. Our EC attended both sessions, making up nearly half of the student participants at the events. The first session was a seminar by former CASA delegate Rebecca Mesay surrounding the role of student organizations in understanding the needs of equity-seeking students. CASA's Executive Director and Government and Stakeholder Relations Officer lead a session on leadership and advocacy training, some

of the tips and tricks to be successful in the long-run. Overall, all the sessions have been amazing and I'd encourage Councillors to try and attend them! These sessions are open to delegates (Presidents and VPEs), executives, and Councillors. Next time there's a session, I'll make sure to send out an email once again.

Two and a half months down, 9 and a half to go. I feel like it's a general trend, but I'm always shocked by how times flies and it's been especially more noticeable to me since being an executive. Vice President Academic July 21st, 2021

Greetings Council,

It's summer and it's hot out there! Hope you are all staying cool and staying hydrated this past month. Please find my report below detailing events that occurred between June 11th and July 14th.

Student Experience and Engagement

Steering Committee - Moodle Implementation Project

The steering committee met twice in this reporting period, with minimal updates for Council's consideration. Starting on July 5th, 33 faculty members who had signed up were given early access to paskwâwi-mostos mêskanâs. Plug-ins and additional supports are being analyzed for their implementation for the September pilot.

APCA "Pivot Your Programs!" Webinar

Attended a short, interactive webinar looking at student body reengagement with their respected Student Association/Union as we come out of the COVID times. Specifically, focused in on student governance engagement and recruitment as personal interest.

Student Voice

Working Group on Minors

We met to establish the priorities and work plan of this working group, determining our schedule for Fall. It was decided that instead of operationally placing myself in one of the groups focused on priority development, the student representative is better suited for a generalized consultant role.

MacEwan Academic Advising Steering Committee

Welcoming Tim Tang, AVP, Students to the committee, updates to the website revisions were reviewed and the future of the steering committee for the 2021-2022 academic was discussed to create a community of practice.

Edmonton Region Post-Secondary Mental Health Committee

Spoke to the Chair of ERPSMHC to get a read on where the committee is currently at in terms of initiatives and focus. With the onset of the first coronavirus lockdown, basically all projects were set on pause until further notice, to not overwhelm the members' capacities.

General Faculty Council

A number of motions were passed at this final GFC for the academic year, packing the agenda. The interdisciplinary film, songwriting, and digital experience design minors passed, along with the suspension of the engineering transfer program. Revisions to the Grading Policy and Student Advisory Council Policy were also passed motions.

GFC Executives Committee

Additional appointments to GFC were made, including a student member who applied through our Committees recruitment (https://samu.ca/macewan-committees/), with only one student seat remaining for this academic year. Discussion of the extension of online delivery disclaimer language in course outlines was a hot topic for a good extension of this meeting.

Faculty of Arts and Sciences Council

A number of reports were brought up for the last FAS Council meeting of the year. The Council had the joy of approving thirty-three motions within the Curriculum package, regarding changes for each of the programs within the Faculty. The Degree-Level (Program) Learning Outcomes was also up for approval.

Stonewall Rally

SAMU EC attended the small, but might march and rally in downtown Edmonton on one of the hottest days of the heat wave we received. Unexpectedly a bonding experience between us, there was quite a few great speakers and performances we got to support, being one of the first in-person events we have all done together.

SAVP/Provost 1:1

In speaking to Dr. Craig Monk, the topics discussed were the messaging around fall, including format, and convocation in what is being done for students afterwards. MacEwan approximately has 20% of classes online in a normal year, but Fall 2021 will have 25-35% online as many students have reservations to returning to in-person still. If a class is listed as virtual, it will be *staying* virtual for the semester. Hybrid classes will also remain as students signed up for them originally, although as it stands, more face-to-face components to these hybrid classes is the current trajectory.

Student Supports

Appeals

I faced the tail end of Requirement-to-Withdraw appeals for this academic year and officially handed over the appeals support to Isha. The new service with Isha is officially called Guided Academic Policy & Procedure Support (GAPPS)! My office hours have been much quieter with this transition.

Academic Misconduct Restorative Conference

After receiving a rundown on what to expect and training as outlined in my last report, I attended as the student body representative for a restorative resolution to outline the harms to the individual, classroom and community a repeated academic misconduct offence entails. The process went fairly well and a fair outcome was decided on by all parties.

Strengthening SAMU Operations

Intro to Local Committee - SRP



With the initial meeting to go over what the Student Refugee Program is going to look like in the upcoming months, our SA VP Student Life and I have signed on to help support the student housed in this program during our terms.

Canadian Symposium on Academic Integrity

I attended this virtual conference on academic integrity, with several guest speakers who outlined different issues on this topic, including seeking out more inclusive restorative approaches in handling and enforcing this issue. MacEwan's Academic Integrity Office held their own presentation on the benefits and application of Restorative Conferences, with our own past SA VP Academic, Alycia Stewart being one of the presenters. Quite a bit of useful knowledge was explored in this two day event.

AMICCUS-C EDI Panel

Attended this virtual panel with a handful of other SAMU staff members including EC. Discussion by panelists from different institutions spoke on the challenges and needs to diversify campuses in becoming more equitable and inclusive to students from backgrounds that have not previously been catered to in the post-secondary sector.

Closing Remarks

The past month has really slowed down for the SAMU Executive Committee. It's given us some time to bond, a break from committee meetings and lots of open office hours. Vice President External July 21, 2021

Hello Councillors,

The following is a summary of the Vice President External (VPE) activities since the June 16th meeting.

Advocacy:

Weekly Housekeeping: VPE Edition and AC/VPE debrief (ongoing)

The Advocacy Coordinator (AC) and I continued to have our weekly meetings at the beginning and end of each week. Together, the AC and I have worked on a variety of projects detailed later in this report for Council of Alberta University Students (CAUS) and the Canadian Alliance of Student Associations (CASA). Some of the larger projects include working on the observer document for CASA, and my CASA board report for the upcoming year.

Weekly general CAUS meetings (every Monday)

Thankfully, we passed four of the five priorities for CAUS in the upcoming year. These are "Healthy and Safe Campuses" (essentially sexual violence prevention and mental health rolled into one), "Student Financial Aid" (specifically focusing on increasing upfront, needs-based, non-repayable grants), "Expanding Affordable Child Care" (as per a federal incentive towards 10\$/day daycare), and Expanding Access to Broadband Internet (primarily for rural students and/or indigenous students on reserves who are less likely to have access to internet conducive to learning in an online environment). I am also proud to say that we are going to develop a specific ask for indigenous students as one of our five priorities for the year. I am personally in favour of advocating for provincial funding towards the creation and maintenance of indigenous centers (such as MacEwan's own kihêw waciston). Lastly, we also unanimously passed a membership fee increase by Consumer Price Index (CPI) for the upcoming year.

Weekly CAUS C/VC/ED meetings (every Thursday)



Myself, the CAUS Chair (Rachel Timmermans), and the Executive Director (Jon Mastel) have spent a good deal of time these past few weeks planning the upcoming CAUS Counterparts conference! In essence, this is a conference where the various executive teams (not just the President and VPE!) of CAUS can come together to discuss everything from best practices to policy direction. This conference will be in Lethbridge, with most members attending in person. As Vice Chair, I have also made it a priority for me to facilitate and create a hybrid model to be used for this and future conferences of CAUS. With Athabasca University Students Union (a Student Union for an online university) as a CAUS member now, it is very likely that we will continue to have conferences long post-COVID that require some members to attend online.

Weekly Alberta Counsel (ABC) meetings (every Wednesday)

Unfortunately, our previous ABC contact no longer works for the organization. However, the CAUS chair and I were introduced to Aaron Singleton who will be taking over our portfolio. We are excited to work with him to further the interests of Alberta's undergraduate students.

Monthly Meeting with MacEwan's Director of Government Relations, Theresa Vladicka (June 21st)

Theresa and I discussed some of the upcoming changes to the post-secondary landscape that the Minister is proposing related to systems governance. In essence, MacEwan's approach is very similar to SAMU's on the topic. We both believe that the committees as they are proposed now would stifle MacEwan's voice at the provincial level, and we look forward to what alternatives will be proposed by the Ministry of Advanced Education. We would also prefer a systems governance model that includes other ministers (not just Advanced Education), as post-secondary has immediate impacts on more than just the post-secondary realm itself.

Weekly External Strategy Group (ongoing)

Myself, the President, General Manager, and Advocacy Coordinator began recurring meetings where we can share information related to our various external advocacy capacities and better define our approaches. These meetings prove very helpful, as Myles and I have very different obligations to CASA and CAUS this year.



CASA Board Call (every other Friday)

The CASA board agreed to meet every other Friday for our regular meetings. So far, we have been hard at work on our board action plans. I have recently finished this labour-intensive project with the help of our Advocacy Coordinator, and come up with 8 separate goals I wish to pursue for the upcoming year. If you would like to know more about them, please let me know! As Director of Membership, much of what I will do to engage the CASA membership will also translate to my duties as LRC chair at SAMU. My hope is that these will be complementary, and I will be able to better engage with Students' Council as a result of what I learn at CASA.

CASA Membership Team Meetings (every other Thursday)

I began recurring meetings with CASA's Member Relations Officer, my staff counterpart at the organization. We planned the upcoming Member Relations Committee (MRC) meeting, where we will begin to enact some of the things in the board action plan. We will begin by working on better reporting mechanisms for CASA, largely inspired by the structures at SAMU's SC meetings.

Edmonton Student Alliance meeting (June 29th)

Thankfully, we were able to have our first meeting of the ESA, a group that represents all of the post-secondary institutions in Edmonton (as the name would suggest). I am happy to say that my counterpart Christan Fotang of the University of Alberta Students' Union (UASU) was elected as Chair of the ESA. Our primary focuses in this group is on the municipal level, and therefore transit, housing, and the upcoming city council election are the topics of recent discussion. I am happy to say that there is interest in a mayoral candidate forum for the election in the fall.

Bilateral meetings:

Marley Gillies, University of Calgary Students' Union (UCSU) VPE (June 24th)

CAUS chair Rachel and I met with UCSU to better understand some of their concerns with respect to an organizational review of CAUS. I appreciated the frank and open conversation, and the Chair and I were better able to understand how to ensure UCSU's concerns are well understood and acted upon.



Rachel Timmermans, SAMRU VPE, CAUS Chair (ongoing)

Rachel and I have met well over a dozen times in the last month to plan the upcoming CAUS Counterparts meeting in Lethbridge. While I have little to add other than what I have said previously, I should be clear that it takes a lot more effort than I anticipated to coordinate even a small event like this one. That being said, I am confident that we are going to deliver a much needed in-person event for the CAUS membership.

Other:

Democratic Exchange Seminar (June 24th)

I attended a lovely seminar where I was given key information on how to approach a Get Out the Vote campaign. As there are two, maybe three elections on the horizon (SAMU, municipal, and likely federal), this information is already proving useful. The greatest takeaway was that we need to stress to young adults that voting is easy, not that it is important. The fear of voting taking a long time is the biggest deterrent to young people casting their votes.

CASA Board Retreat (June 18th and 22nd)

I had my digital board retreat with the incoming board for CASA, where the 7 of us got acquainted with one another as well as the Hom(i)e office staff out in Ottawa. We also got the ball rolling on our board action plans, as mentioned above.

Youth Vaping Meeting (June 25th)

I met with Avneet Mangat of Action on Smoking and Health (ASH) to discuss the scourge of nicotine addictions afflicting the young adults that attend post-secondary institutions. I was able to share some of my own struggles with nicotine, as well as gain some insight into how we can delineate information to students about the dangers of nicotine without sounding like Steve Buscemi in 30 Rock. We plan on having additional meetings in the near future on the topic of student engagement on matters related to their own health.

Thankfully, this has proved to be a shorter report than last time. In keeping with that theme, I will keep my comments here short. Hopefully LRC will soon be able to meet, as I have already learned so much from my time at CAUS and CASA and I am very excited to apply that knowledge to SAMU. EDI in Governance

This is the report from the Budget and Finance Committee for the reporting period of April 1st to June 30th (Quarter 4 2020/21)

BFC met twice during this reporting period, once in April and once in May.

April: At this meeting BFC had discussions on the SAMU fees and our Ponoka students. After getting the numbes from finance it was calculated that there would only be a small decrease in fees for students at the Ponoka campus and it was determined that the fee should be kept standard but we should focus on increasing our services and better promoting our services at that campus to those students. Also at this meeting BFC recommended that part time students who are being considered fulltime students should be assessed nine credits worth of fees as fulltime status is defined as nine to fifteen credits.

June: This meeting brought a change in the Finance policy to BFC. Now that we have a new building our surplus shows a negative numbe due to the amortization that occurs each year, since amortization is a non-cash item it doesn't affect the surplus that we allocate into our Maintainence, Major expenditure and SAMU Cares Endowment funds at the end of each fiscal year. What was proposed and ultimately recommended to council was adding wording to the policy that excludes amortization from the operating surplus at then end of the year.

Roles and Responsibilities of the Secondary Student Delegate policy: This was the one policy that didn't come forward to students council as there were no changes decided upon from BPC. Discussion around this policy included whether the policy should be retired, as it has not been utilized previously. BPC decided that we will keep it as is for

Student Voice on Violence Elimination Sub-Committee

Mandate

1 The Student Voice on Violence Elimination Sub-Committee identifies, discusses, and provides feedback on topics surrounding campus sexual violence and the effectiveness of SAMU sexual violence prevention advocacy efforts. It reports to SAMU's Executive Committee and advises MacEwan's Sexual Violence Prevention and Education Committee (SVPEC) on issues of campus sexual violence.

Roles of Committee

- 2 The Student Voice on Violence Elimination Sub-Committee reviews data and material relevant to student experiences of campus sexual violence at MacEwan University and related topics (ex. Campus Climate Survey, NCHA data).
- **3** The Student Voice on Violence Elimination Sub-Committee collects information on and consults students on campus norms around consent education and sexual violence prevention.
- **4** The Student Voice on Violence Elimination Sub-Committee inventories and suggests enhancements to services, initiatives, and educational programming around campus sexual violence put on by SAMU and/or MacEwan through reporting.

Composition

- 5 Voting members of the Student Voice on Violence Elimination Sub-Committee are one Executive, two Councillors, one Residence representative (to be selected by Residence), and three students at large.
- 6 Members will serve one-year terms (April-March).
- **7** MacEwan's Sexual Violence Prevention & Education Coordinator and VP General Counsel serve as resource officials.
- 8 Any Executive is entitled to attend a committee meeting in a non-voting capacity.

Committee Operations

- **9** Meetings of the Student Voice on Violence Elimination Sub-Committee are held at least once every three months.
- **10** The committee Chair may call additional meetings as required.
- **11** The committee submits reports quarterly.

Leadership and Review Committee

Mandate

1 Leadership and Review Committee is a semi-judicial body which advises and reviews Students' Council, and strives to maximize student engagement.

Roles of Committee

- 2 Leadership and Review Committee reviews the performance of the Chair of Students' Council.
- **3** Leadership and Review Committee reviews Students' Council's decisions in relation to their adherence to SAMU Bylaws and Policies.
 - **3.1** Leadership and Review Committee may call a re-vote on a decision where it deems the decision was a violation of Bylaws or Policies.
 - **3.2** Members of Students' Council may request a review of a decision in relation to its adherence to Bylaws and Policies.
 - **3.2.1** Requests must be made in writing to the Chair of Leadership and Review Committee within 10 days of the disputed decision.
 - **3.2.2** Leadership and Review Committee will have 30 days to respond in writing to Students' Council with its decision.
- **4** Leadership and Review Committee creates opportunities for members of Students' Council to develop leadership skills by:
- **4.1** researching and implementing applicable professional development opportunities for members of council; and
 - **4.2** developing team building opportunities for Students' Council.
- **5** Leadership and Review Committee develops a plan for Student Council to engage with SAMU members.
- **6** Leadership and Review Committee reports on the effectiveness and progress of Students' Council.

Composition

- **7** The voting members of Leadership and Review Committee are one Executive, two Councillors, and two students-at-large.
- 8 The resource official of Students' Council Review Committee is the Governance Advisor.
 - **8.1** Any member of Students' Council is entitled to attend a committee meeting in a non-voting capacity.



Committee Operations

Meetings of Leadership and Review Committee are held at least twice per quarter.

The Committee Chair may call additional meetings as required.
