# STUDENT AFFORDABILITY SURVEY – 2024 OFFICIAL CONTEST RULES February 9, 2024

This contest is open to Canadian Residents, excluding Quebec, who are currently enrolled in MacEwan University and is governed by Canadian law.

#### 1. CONTEST PERIOD:

Contest begins on February 12, 2024 at 8:00 a.m. MDT and ends on February 19, 2024 at 11:59 p.m. MST (the "Contest Period"). The Students' Association of MacEwan University reserves the right to extend the contest period in to increase the number of completed surveys.

#### 2. ELIGIBILITY:

This contest is open to Canadian residents who are the age of majority in their province of residence, excluding Quebec residents ("Entrants"). Entrants must be a current MacEwan student or a 2023 graduate. The contest is sponsored by Students' Association of MacEwan University (SAMU) (the "Sponsor"). Employees of SAMU and MacEwan University, including faculty members, are not eligible to enter this contest.

#### 3. HOW TOENTER:

No purchase necessary. Only one entry per student. To enter, Entrants must fully complete the Student Affordability Survey –2024 located at <a href="https://samu.ca/affordability">https://samu.ca/affordability</a> (the "Website") or directly at <a href="https://www.surveymonkey.com/r/2767B97">https://www.surveymonkey.com/r/2767B97</a> and follow on-screen instructions which require you to (i) provide your opinion and answers to the questions provided in the survey hosted on Survey Monkey website, (ii) provide contact information for contest purposes and (iii) agree to the terms and conditions of these Official Contest Rules and Regulations (the "Rules"). Once you have fully completed the survey, provided contact information, click the submit button to complete your entry ("Entry", collectively "Entries"). By entering the contest, you are agreeing to these Rules & Regulations. To be eligible, your Entry must be received within the Contest Period.

#### 4. HOW TO WIN

Winners will be selected by random draw within three days of the close of the Contest Period ("Draw Date"), from among all eligible Entries received during the Contest Period.
