

STUDENT AFFORDABILITY SURVEY – 2024
OFFICIAL CONTEST RULES
February 9, 2024

This contest is open to Canadian Residents, excluding Quebec, who are currently enrolled in MacEwan University and is governed by Canadian law.

1. CONTEST PERIOD:

Contest begins on February 12, 2024 at 8:00 a.m. MDT and ends on February 19, 2024 at 11:59 p.m. MST (the “**Contest Period**”). The Students’ Association of MacEwan University reserves the right to extend the contest period in to increase the number of completed surveys.

2. ELIGIBILITY:

This contest is open to Canadian residents who are the age of majority in their province of residence, excluding Quebec residents (“**Entrants**”). Entrants must be a current MacEwan student or a 2023 graduate. The contest is sponsored by Students’ Association of MacEwan University (SAMU) (the “**Sponsor**”). Employees of SAMU and MacEwan University, including faculty members, are not eligible to enter this contest.

3. HOW TO ENTER:

No purchase necessary. Only one entry per student. To enter, Entrants must fully complete the Student Affordability Survey –2024 located at <https://samu.ca/affordability> (the “**Website**”) or directly at <https://www.surveymonkey.com/r/2767B97> and follow on-screen instructions which require you to (i) provide your opinion and answers to the questions provided in the survey hosted on Survey Monkey website, (ii) provide contact information for contest purposes and (iii) agree to the terms and conditions of these Official Contest Rules and Regulations (the “**Rules**”). Once you have fully completed the survey, provided contact information, click the submit button to complete your entry (“**Entry**”, collectively “**Entries**”). By entering the contest, you are agreeing to these Rules & Regulations. To be eligible, your Entry must be received within the Contest Period.

4. HOW TO WIN

Winners will be selected by random draw within three days of the close of the Contest Period (“**Draw Date**”), from among all eligible Entries received during the Contest Period.

The odds of winning depend on the number of eligible Entries received during the Contest Periods.

The Sponsor will make three (3) attempts to contact the selected entrant(s) by telephone or email (using the information provided at the time of entry) within five (5) business days of the Draw Date. If a selected entrant cannot be contacted or has not responded within (10) days of the Draw Date or there is a return of any notification as undeliverable; then that selected entrant will be disqualified and the Sponsor reserves the right, in its sole discretion and subject to time constraints, to randomly select an alternate eligible entrant from among the remaining eligible Entries.

All Entries are subject to verification. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in this Contest. Failure to provide such proof in a timely manner may result in disqualification.

5. PRIZES

The total value of the prizes is \$1000.00. All prizes will be presented in the form of digital or physical gift cards to a grocery store of the Sponsor’s choice. All prizes must be accepted as awarded. The Sponsor reserves the right to

substitute any of the prizes with other prizes of equal or greater value if any prize cannot be awarded as described for any reason. Prizes are non-transferable and are not redeemable for cash or credit, in whole or in part.

The Sponsor may require winners to sign a liability/publicity release, including a consent to the Sponsor posting the winner's name and photograph on its website or through its social media channels. If a winner fails to return the contest documents within the time specified by the Sponsor, s/he will forfeit their prize, at the discretion of the Sponsor, and an alternate winner will be selected.
