# SAMU Municipal Election Forum Contest – 2025 OFFICIAL CONTEST RULES Sep 8, 2025

This contest is open to Canadian Residents, excluding Quebec, who are currently enrolled in MacEwan University and is governed by Canadian law.

#### 1. CONTEST PERIOD:

Contest begins on September 8, 2025 at 9:00 a.m. MDT and ends on Sep 26, 2025 at 7:30 p.m. MDT (the "Contest Period").

#### 2. ELIGIBILITY:

This contest is open to Canadian residents who are the age of majority in their province of residence, excluding Quebec residents ("Entrants"). Entrants must be a current MacEwan student. The contest is sponsored by Students' Association of MacEwan University (SAMU) (the "Sponsor"). Employees of SAMU and MacEwan University, including faculty members, are not eligible to enter this contest.

#### 3. HOW TOENTER:

No purchase necessary. Only one entry per student. To enter, Entrants must complete the registration form and view the contest rules located at <a href="mailto:samu.ca/mayoralforum">samu.ca/mayoralforum</a> (the "Website"). To be eligible, your Entry must be received within the Contest Period.

#### 4. HOW TO WIN

The winner will be selected by random draw of registered MacEwan Student attendees at the Municipal Election Forum on September 26, 2025 ("**Draw Date**"), from among all eligible Entries received during the Contest Period. Only one winner will be selected for this Contest.

Before being declared a winner, the selected entrant will be required to correctly answer a mathematical skill-testing question without mechanical or other aid and sign a prize acceptance form.

The odds of winning depend on the number of eligible Entries received during the Contest Period.

The selected entrant must be present at the Municipal Election Forum on September 26, 2025 to claim their prize. Upon confirmation, the entrant will be required to complete a prize acceptance form. If the selected entrant is not present at the Municipal Election Forum, then that selected entrant will be disqualified and the Sponsor reserves the right, in its sole discretion and subject to time constraints, to randomly select an alternate eligible entrant from among the remaining eligible Entries.

All Entries are subject to verification. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in this Contest. Failure to provide such proof in a timely manner may result in disqualification.

#### 5. PRIZES

The total value of the prize is \$500 CAD. The prize will be digitally administered to the winner's MacEwan University Finance account or loan provider, as applicable. The prize must be accepted as awarded. The Sponsor reserves the right to substitute the prize with other prizes of equal or greater

value if any prize cannot be awarded as described for any reason. The prize is non-transferable and is not redeemable for cash or credit, in whole or in part.

The Sponsor may require winners to sign a liability/publicity release, including a consent to the Sponsor posting the winner's name and photograph on its website or through its social media channels. If a winner fails to return the contest documents within the time specified by the Sponsor, they will forfeit their prize, at the discretion of the Sponsor, and an alternate winner will be selected.
