

SUPPORT KITS CONTEST 2026

OFFICIAL CONTEST RULES

March 2 – 20, 2026

This contest is open to Canadian Residents, excluding Quebec, who are currently enrolled in MacEwan University and is governed by Canadian law.

1. CONTEST PERIOD:

This contest opens at 8:00a.m. on March 2 2026, and closes at 4:00 p.m. March 20, 2026. (the “Eligibility Period) OR when all SAMU Support Kits are claimed. Participants must register to receive a SAMU Support Kit within the Eligibility Period to be eligible to receive a prize.

2. ELIGIBILITY:

This contest is open to Canadian and foreign students attending MacEwan University in Canada who are the age of majority in their province of residence, excluding Quebec residents (the “Entrants”). Entrants must be a current full-time or part-time MacEwan student enrolled in the 2026 school year. The contest is sponsored by the Students’ Association of MacEwan University (SAMU) (the “**Sponsor**”). Employees of SAMU and MacEwan University, including faculty members, are not eligible to enter this contest.

3. HOW TO ENTER:

No purchase necessary. Only one entry per student. Entrants may enter the draw anytime within the Eligibility Period.

Entrants are eligible to enter the Contest once within the Eligibility Period. To enter, Entrants must register to receive a SAMU Support Kit. When registering for their Kit, students will have the option to request to enter to Support Kit Contest draw. For a registration to be considered an Entry, students must indicate they wish to enter the draw. By submitting their Entry, all Entrants are agreeing to the terms and conditions of the contest and these Official Contest Rules and Regulations (the “Rules”).

4. HOW TO WIN:

The Winners will be selected by random draw starting on March 23, 2026, from among all eligible Entries received during the Eligibility Period (the Winners). The Winners will be contacted by email and/or phone. Before being declared Winners, the selected entrants will

be required to correctly answer a mathematical skill-testing question without mechanical or other aid and sign a Prize Declaration and Release form.

The odds of winning depend on the number of eligible Entries received during the Eligibility Period. The Sponsor will make three (3) attempts to contact the Winners by email and/or telephone (using the information provided at the time of entry) from the time the Draw is made through to March 30, 2026, at 12:00 p.m. local time.

If the selected Entrant(s) cannot be contacted or have not responded after three tries through email and/or phone by March 30, 2026 at 12:00 p.m., or there is a return of any notification as undeliverable; then selected Entrant(s) will be disqualified and the Sponsor reserves the right, in its sole discretion and subject to time constraints, to randomly select an alternate eligible Entrant(s) from among the remaining eligible Entries.

5. **All Entries are subject to verification. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in this Contest. Failure to provide such proof in a timely manner may result in disqualification.**

6. **PRIZES:**

The total value of all prizes in this contest is approximately \$450 CAD. The table below contains all prizing details:
